Executive Summary

Public Hearing for the construction of the Manor Drive Storm Water Improvement Project. An Interested Parties (IP) meeting for this project was held on December 9, 2015, with four property owners attending.

Discussion

As early as May of 2002, the Storm Water Utility has been receiving complaints from homeowners in the area concerning holes forming in their yards due to the failing private stormwater system currently in place on Manor Drive. On June 24, 2013, operations personnel inspected the private stormwater pipe which drains the sump in Manor Drive. The pipe runs between 404 and 408 Manor Drive. The inspection revealed that the pipe is collapsing approximately 85 feet downstream from Manor Drive, causing stormwater to back up into the street in excess of twelve inches deep. The current private stormwater system does not meet City standards and is in need of replacement.

Staff held an Interested Parties (IP) meeting for the project on December 9, 2015, with property owners from four properties in attendance and all in support of the stormwater improvements. Staff has had well received conversations with all affected property owners concerning the proposed preliminary layout.

The preliminary design proposes the construction of approximately 420 linear feet of new stormwater pipe. The proposed stormwater pipe is located through yards to connect the inlets on Manor Drive to the existing public stormwater system on Maplewood Drive. The preliminary layout is shown on the attached "Preliminary Layout." The proposed alignment is different than the existing alignment to avoid impact to mature trees to the greatest extent possible. The proposed system will be properly sized to reduce the occurrence of street flooding, will replace failing pipes and will eliminate the existing open channel.

Total project costs are estimated at \$75,000 and will be paid for by the Storm Water Utility funds.

Staff is attempting to expedite this process so that construction can be coordinated with the Manor Sidewalk Improvement and Manor Waterline Improvement projects.


