# Executive Summary

Appropriating a portion of (Round 2) federal grant funds allocated to the City of Columbia for non-motorized transportation (GetAbout) projects/activities.

Discussion

In 2006, the City of Columbia received a federal grant in the amount of \$22,435,421 to be used for non-motorized transportation projects/activities. In 2011, an extension of the Federal SAFETEA-LU bill resulted in additional funding (Round 2) for Columbia in the amount of \$5,929,975; bringing the total allocated non-motorized transportation grant funds to \$28,365,396.

To date, \$23,659,025 has been appropriated or budgeted to specific non-motorized projects/activities. As projects are winding down and in various stages of completion, staff would like to secure the majority of remaining allocated funds by appropriating \$3,500,000 to the non-motorized transportation capital project account for design and/or construction of the following capital projects:

Fiscal Impact

Short-Term Impact: To date, \$23,659,025 of the \$28,365,396 allocated non-motorized transportation funds have been appropriated or budgeted. Staff is requesting to appropriate an additional \$3,500,000 to the non-motorized capital project account.



Long-Term Impact: Staff anticipates that the last of the projects funded with non-motorized transportation grant funds will be completed by the end of FY2018.

# AN ORDINANCE

appropriating non-motorized transportation (Round 2) grant funds for capital projects and/or activities; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The sum of \$3,500,000.00 is hereby appropriated from the Federal Revenues Project Account No. 440-0000-461.10-00, C00271 to the Non-Motorized Transportation Grant Project Account No. 440-8800-528.49-90, C00271 to offset expenditures for the design and construction of capital projects.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.
