Re: Administrative Public Improvement Project: Chapel Hill Connector to County House Trail

Executive Summary

The public improvement project on the attached form is eligible for the administrative public improvement process. Unless the Council wishes to follow the standard public improvement process, staff will proceed with preparing plans and specifications and bidding the project.

Discussion

Under Section 22-72(c) of the City Code, the City Manager is required to report to the City Council any public improvement project that the Manager has determined meets the eligibility requirements of the Code and should follow the administrative public improvement process. Unless the Council determines that the project should follow the standard public improvement process, the Manager may proceed with the administrative process.

The public improvement(s) on the attached form meet the eligibility requirements for projects that can follow the administrative public improvement process.

Fiscal Impact

Short-Term Impact: The cost of the project is \$10,000 and is funded from the 2010 Park Sales Tax - Annual Trails Funds.

ADMINISTRATIVE PUBLIC IMPROVEMENT PROJECT

Project name and brief description: Chapel Hill Connector to the County House Trail – After the acquisition of a permanent trail easement adjacent to the County House Trail, park staff is proposing to use a combination of contract and force account labor to construct a concrete trail connecting an existing sidewalk along the west bound lane of Chapel Hill Road to the County House Trail. The proposed 200' trail was requested by the developer of the Face Rock Court neighborhood and will connect the Face Rock development, as well as future residential and commercial development in the area, to the County House Trail. The proposed 6' wide concrete trail will be constructed using contract labor, and park staff will complete all necessary backfilling and seeding to complete the project. The total project budget is \$10,000 and will be funded by 2010 Park Sales Tax Annual Trails funds. Staff anticipates that the trail connector will be completed by summer 2016.
