Re: Setting a Public Hearing to Consider the FY 2016 CDBG and HOME Annual Action Plan

#### **Executive Summary**

Staff has prepared a resolution setting a public hearing for April 4, 2016 to consider the 2016 Community Development Block Grant (CDBG) and HOME Action Plan. The 2016 Action Plan must be submitted to the Department of Housing and Urban Development (HUD) in order to receive CDBG and HOME funds. A public hearing is required by HUD in accordance with the City's Citizen Participation Plan. The 2016 Action Plan is the 2<sup>nd</sup> year of implementing the 5-Year Consolidated Plan for 2015-2019. A draft 2016 Action Plan will be available for public review on March 7, 2016.

#### Discussion

HUD requires that the City's 2016 Action Plan be submitted within 60 days of notification of funding allocations. HUD announced funding allocations on February 16, 2016; therefore, the City's FY 2016 Annual Action Plan shall be submitted by April 15, 2016 in order to receive CDBG and HOME funds. The documents are also required for other organizations to receive HUD funding, including Columbia Housing Authority Programs and funding for the homeless through the Continuum of Care. A 30 day comment period is required that will begin on March 7, 2016 and end on April 5, 2016. A public hearing must be held during this public comment period. A hearing is recommended on April 4, 2016. Any comments received prior to the public hearing, and responses, will be provided to the City Council. A full report of the FY2016 Annual Action Plan will be provided to Council prior to the April 4, 2016 hearing.
