Re: Authorizing Long Term Street and Sidewalk Closures on Portions of S. Ninth Street, S. Tenth

Street, Locust Street and the alley between Locust Street and Cherry Street

Executive Summary

Fields Holding, LLC has requested permission to close portions of street and/or sidewalks along S. Ninth Street, S. Tenth Street, Locust Street and the alley between Locust Street and Cherry Street, to demolish and remove three structures and construct a new multi-story, multi-use building. A press release was issued on March 11, 2016 authorizing a 30 day closure beginning March 14, 2016. Long term closures are proposed for April 1, 2016 through August 20, 2017.

Discussion

Fields Holding, LLC will be demolishing two structures on S. Ninth Street and one structure on S. Tenth Street in order to construct a new multi-story, multi-use building, called Rise Apartments. Fields Holding, LLC has requested long term street and/or sidewalk closures on portions of S. Ninth Street, S. Tenth Street, Locust Street, and the alley between Locust Street and Cherry Street. Following is a summary of the closure locations. The attached correspondence from Engineering Surveys & Services provides more detailed information.

Locust Street

- A sidewalk closure on the north side between S. Ninth Street and S. Tenth Street
- Lane restrictions with two lanes of traffic being maintained on Locust Street

S. Tenth Street

- Sidewalk closure on the west side between Locust Street and the alley
- Lane closure on the southbound lane of traffic between Locust Street and the alley

Allev

Closed between Locust Street and Cherry Street

S. Ninth Street

- Overhead protection on a portion of sidewalk between Locust Street and the alley
- Sidewalk will be closed during steel erection

Engineering Surveys & Services have contacted the adjacent property owners (see attached letters). Parking meters will be bagged along the east side of S. Ninth Street, north and south sides of Locust Street, and east and west side of S. Tenth Street. The long term closures will begin at 7:00 AM, Friday April 1, 2016, and end at 5:00 PM, Sunday August 20, 2017.

A RESOLUTION

authorizing the temporary closure of a portion of the sidewalk and traffic shifting and reduction of the vehicular lane width on Locust Street between Ninth Street and Tenth Street, the temporary closure of a portion of the sidewalk and vehicular lane on Tenth Street between Locust Street and the alley, the temporary closure of the alley between Locust Street and Cherry Street, and providing covered protected sidewalk access on a portion of the sidewalk on Ninth Street between Locust Street and the alley to facilitate the construction of a mixed use building.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes Fields Holding, LLC the following temporary closures, traffic shifting and vehicular lane width reductions, as shown on "Exhibit A" attached hereto, from April 1, 2016 to August 20, 2017, to facilitate the construction of a mixed use building on Locust Street between Ninth Street and Tenth Street:

Locust Street

- Temporary closure of the sidewalk on the north side of Locust Street between Ninth Street and Tenth Street.
- Traffic shifting and reduction of the vehicular lane width on Locust Street between Ninth Street and Tenth Street to 11-feet or 12-feet during demolition and construction phases.

Tenth Street

- Temporary closure of the sidewalk on the west side of Tenth Street along the project frontage between Locust Street and the alley.
- Temporary closure of the southbound vehicular lane of Tenth Street between Locust Street and the alley with a limitation to one-way northbound traffic only along the project frontage.

Alley

Temporary closure of the alley between Locust Street and Cherry Street.

Ninth Street

 The sidewalk on the east side of Ninth Street shall be protected with walkway scaffolding to allow pedestrian traffic during demolition and construction; however, intermittent temporary closure shall be allowed when necessary to protect the public safety and to allow for removal and replacement of the existing sidewalk.

SECTION 2. Fields Holding, LLC shall close portions of the streets and sidewalks and reduce vehicle lanes only in accordance with the closure plan submitted and approved by the City's Director of Public Works. In the interest of public safety, the Director of Public Works may require additional traffic control measures by notifying Fields Holding, LLC, in writing, of such requirements. Fields Holding, LLC shall be responsible for all signs and barricades necessary for the protection and convenience of the general public and shall be responsible for the repair of the streets and sidewalks due to any damage caused by the demolition and construction activities. Fields Holding, LLC shall be responsible for notifications to the media and emergency personnel.

SECTION 3. Fields Holding, LLC shall proceed with the demolition and construction activities which require the street and sidewalk closures and vehicle lane reductions without unnecessary delay so as to minimize disruption to the public. Failure to proceed without unnecessary delay may result in the revocation of the closure permit by the City Council.

SECTION 4. The temporary street and sidewalk closures and vehicle lane reductions authorized herein may be terminated by the City Council upon recommendation of the Director of Public Works and a determination such closures and reductions are no longer necessary for the protection of the health, safety and welfare of the public or is otherwise in the best interest of the public.





Dear Mr. Nichols:

An Application for Long Term Road Closure is attached for review and approval for the Rise Apartments project, Plan Review Application No. 16-695. Plan sheets outlining temporary traffic control for the project are attached. The work will entail the demolition of three onsite structures and removal of existing improvements on site for a new multi-story, multi-use building. Areas of sidewalk and road pavement will also be replaced (see plans for more details). Dates for closures are included with this letter and in the long term closure application. A draft closure letter with a listing of adjacent business owners to the project is included as well. This letter will be sent out prior to the closures and received by the business owners at minimum three days in advance of closure. Existing sidewalk brick will be removed and reused as extensively as possible. Any sidewalk brick that is broken or worn beyond use will be replaced with new brick with a similar size, shape, and color of the brick around it.

Dates of Closures or restrictions:

- 1. Partial or full closures of streets and sidewalks are proposed between Friday, April 1, 2016, at 7:00 AM to Saturday, August 20, 2017, at 5:00 PM.
- 2. Demolition Phase:
 - a. Approximate dates from April 1, 2016, to May 31, 2016;
 - b. Bag meters along east side 9th Street, north and south side of Locust Street, and east and west side of 10th Street along project frontage;
 - c. Reduce traffic on Locust Street and 10th Street to 12 foot lanes;
 - i. Route traffic along parking area on south side of Locust Street and east side of 10th Street;
 - ii. 10th Street to be limited to one-way northbound traffic only;
 - d. Close the sidewalk along the 10th Street and Locust Street project frontage;
 - e. Protect the sidewalk along the 9th Street project frontage with scaffolding (attached).
- 3. Construction Phase Steel Erection:
 - a. Approximate dates from June 1, 2016, to August 31, 2016;
 - b. During this time a crane will be onsite which will require a 37 foot x 37 foot clear area;

- c. Bag meters in accordance with demolition phase;
- d. Reduce traffic on Locust Street and 10th Street to 11 foot lanes;
 - i. Route traffic along parking area on south side of Locust Street;
 - ii. 10th Street to be limited to one-way northbound traffic only;
- e. Closure of sidewalks along 10th Street and Locust Street project frontage;
- f. Protect the sidewalk along the 9th Street project frontage with scaffolding.
- 4. Construction Phase After Steel Erection:
 - a. Approximate dates from September 1, 2016, to August 20, 2017;
 - b. Bag meters in accordance with demolition phase;
 - c. Reduce traffic on Locust Street and 10th Street to 12 foot lanes;
 - i. Route traffic along parking area on south side of Locust Street and east side of 10th Street;
 - ii. 10th Street to be limited to one-way northbound traffic only;
 - d. Close the sidewalk along 10th Street and Locust Street project frontage;
 - e. Intermittently close the sidewalk along the 9th Street project frontage to allow the removal and replacement of the existing sidewalk;
 - f. During this time, road and sidewalk closures may be reduced or eliminated due to exterior work being completed.
 - i. The exact schedule of exterior work completion has not been finalized.

Fields Holdings, LLC has been working with the neighboring properties throughout the design phase of this project.
