Re: Amending the General Cooperative Agreement with Boone County Regional Sewer

District

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute Amendment No. 4 to the March 8, 2011 General Cooperative Agreement with Boone County Regional Sewer District (BCRSD). This amendment provides public sanitary sewer service to 801 and 809 Happy Hollow Road.

Discussion

In June 2006, the City and BCRSD entered into an agreement relating to sanitary sewer service for property located in Happy Hollow Estates Subdivision and other subdivisions and locations. This agreement identified BCRSD and City customers in the Happy Hollow Subdivision.

In March 2011, the City and BCRSD entered into a general connection agreement authorizing BCRSD to connect existing customers in the State Highway HH area, Westwood Meadows Subdivision, El Rey Heights Subdivision and Cow Branch Watershed area. The 2011 general connection agreement also renewed previous 20-year wholesale treatment agreements that had lapsed for the Little Bonne Femme area and the Jerry Morris Subdivision.

The March 2011 general connection agreement was amended in March 2013, renewing a previous 10-year wholesale treatment agreement that had lapsed for the Water's Edge, Lakewood Villas, Lakewood Estates, Lakeland Acres and Pin Oak Subdivision Service area. The general connection agreement was amended a second time in May 2014 to connect the Abilene Acres Subdivision to City sewer. The third amendment was in August 2015 to identify the customer service area for Midway and the Henderson Branch Sewer Extension.

Amendment No. 4 to the General Cooperative Agreement updates the Boundary Area covered by the agreement to include 801 and 809 Happy Hollow Road as shown on Exhibit 10 in the Agreement. The exhibit identifies existing BCRSD and City customers and BCRSD customers required to annex and develop to city standards in order to connect to the public sewer. All other general and special conditions stipulated in the March 2011 agreement remain the same, where treatment costs are charged to BCRSD at 80% of the current sewer rates for the properties served.

WHEREAS, the General Cooperative Agreement contemplated that said agreement may be amended from time to time by adding, deleting, and/or revising the Special Conditions and Exhibits as needed and as mutually agreed upon by the Board of Trustees of the District and the City Council of the City; and

WHEREAS, the following are the revisions to the GENERAL CONDITIONS and the SPECIAL CONDITIONS of the General Cooperative Agreement.

REVISIONS TO THE GENERAL CONDITIONS

- 1. Section 1 is deleted in its entirety. In its place a new Section 1 is included, as follows:
 - 1. The scope of the this agreement is limited to those geographic areas within the "Boundary of Area Covered by Agreement" on the attached Exhibits 1 through 10, both inclusive, and which are entitled "State Highway HH Cooperative Agreement", "Westwood Meadows Cooperative Agreement", "El Rey Heights Cooperative Agreement", "Cow Branch Watershed Cooperative Agreement", "Little Bonne Femme Pump Station Cooperative Agreement", "Jerry Morris Subdivision Cooperative Agreement", "Water's Edge, Lakewood Villas, Lakewood Estates, Lakeland Acres and Pin Oak Subdivisions Service Area", "Abilene Acres Connection Agreement", "BCRSD Midway Connection Agreement Map" and "Happy Hollow Estates".

All other GENERAL CONDITIONS of the original March 8th, 2011, General Cooperative Agreement shall remain in effect.

END OF GENERAL CONDITIONS, BEGINNING OF SPECIAL CONDITIONS

SPECIAL CONDITIONS

- 1. Add the following Special Condition 11.
 - 11. The City and District agree that the customers in the District's service area shown on Exhibit 10, "Happy Hollow Estates" are and shall remain connected to the City's wastewater treatment and collection system as provided for in the GENERAL CONDITIONS of this agreement.
