Re: Appropriation of Share the Light funds

## Executive Summary

The Share the Light program began in August 2001 as a way for residents to contribute to a range of City of Columbia projects through their utility bill on a one-time or monthly basis. As of February 1, 2016, more than \$233,900.00 has been raised for six areas of city programming. The six areas are community arts programming, community beautification, youth recreation scholarships, public health, fire prevention and education, and crime prevention. Each donation is made for a specific area of programming and is to be used only for programming in that area of giving. Staff is requesting appropriation of Share the Light funds already donated for use by the Columbia/Boone County Public Health and Human Services Department.

## Discussion

The Share the Light program allows Columbia residents to contribute to one or more of six areas of city programming that extend beyond basic City services. The six areas are community arts programming, community beautification, youth recreation scholarships, public health, fire prevention and education, and crime prevention. Since Share the Light started, more than \$200,400.00 has been appropriated (including this request) throughout all six program areas.

Staff asks that \$4,292.74 in Share the Light funds be appropriated for Columbia/Boone County Public Health and Human Services Department for two programs. Of that total, \$2,146.37 will help fund the Childcare Nurse Consultant annual training for childcare facilities and childcare providers. This training educates childcare providers in how to teach preschool children the correct way to brush and floss teeth; it also provides supplies (toothbrushes, timers for brushing, toothpaste and floss) so that the facilities can afford to carry out an ongoing program. The program seeks to cut down on pediatric dental caries and encourage good dental hygiene. Facilities that have had the training in the past can receive more toothbrushes and toothpaste to continue their programs. Last year, over \$2,500 was spent on the training and support of the facilities for their oral health programs.

The remaining \$2,146.37 will help fund Adult Indigent Care, a program that provides sharps containers for individuals who use syringes and lancets for insulin or other injectable medications, and a disposal service for full boxes. This program has a two-fold focus: to give low income individuals a safe way to dispose of their used syringes and to keep these potentially hazardous sharps out of the trash. During FY15, \$2,280 was spent for the purchase of personal sharps containers and their disposal.

SECTION 1. The sum of \$4,292.74 is hereby appropriated from the Share the Light Utility Charges Public Health Account No. 753-8500-480.50-44 DYDNTL to the Health Department Administration Miscellaneous Supplies Account No. 110-3310-531.13-95 SHAREH for the purchase of dental supplies and training materials, sharps containers for syringes and lancets and disposal services for full sharps containers.
