COLUMBIA PARKS & RECREATION DEPARTMENT
Park Services Division
Monthly Report

I. ADMINISTRATION

- A. Received notification from the Department of Natural Resources that the City of Columbia has been awarded a Recreational Trails Program Grant in the amount of \$42,000 to fund the development of a 5,500 ft.-long gravel nature trail in the Garth Nature Area, including signage, wetland areas, benches and a drinking fountain.
- B. Received a 2005 Tree City Growth Award from the National Arbor Day Foundation for the City's achievement in environmental improvement and strengthening local tree care programs.
- C. Bristol Lake Investments, LLC donated the 62.95-acre lake tract of the Philips property on December 30, 2005, having completed the lake improvements required by the City/Bristol Lake purchase agreement.
- D. Contractor (Wood Link Fence Company) completed the dog park fence project at Twin Lakes Recreation Area.
- E. Contractor (Huebert Builders) completed the masonry work and roofing for both the Stephens and Nifong restrooms (excluding the exterior stone facade).
- F. Contractor (Crawford Construction) completed the majority of the masonry work and roof framing at the Antimi concession and restroom project.
- G. Contractor (Frech Paving) completed the asphalt portion of the Riechmann Pavilion parking lot and the Broadway entrance at Stephens Lake Park.
- H. Contractor (Adair Construction) completed the concrete patios and service drive at Riechmann Pavilion.
- I. Contractor (Russell-Marti Conservatory - general contractor, Huebert Builders - subcontractor) completed the tile replacement at MLK Memorial, installation of a second French drain, and removal of all brick and mortar from the upper walkway. (Joint project with Cultural Affairs.)
- J. Contractor (Sun Belt Environmental Services) installed a construction fence on site in preparation for Flat Branch II Brownfield environmental cleanup.
