Lead in the water

Columbia's water system—Columbia's water comes from an aquifer in McBaine, Mo., not the Missouri River, and is a very clean source for drinking water. The water meets or exceeds any drinking water standards set by the Environmental Protection Agency (EPA). The Missouri Department of Natural Resources is responsible for enforcing the federal water quality standards.

Lead In Columbia's water supply—Over 30 years ago, Columbia Water & Light started removing lead pipes in Columbia's water system. The pH level of Columbia's water is 8.33 which means it is more basic and less acidic. More acidic water can leech lead from pipes.

Fifty water distribution samples from customers' buildings are checked for lead every three years. One customer sample exceeded the lead action level and was notified. The measurements ranged from undetected to 36.3 micrograms per liter. Compliance is determined by the 90th percentile, which was 2.63. The Action Level set by the EPA is 15 micrograms per liter.

Lead in customers' plumbing—Columbia Water & Light's system, in most instances, ends at the customers' meters. Pipes from the meter to the building and any interior pipes are private property. If a person has an older building where there are lead pipes or lead might have been used in soldering two pipes together, the customer could have higher levels of lead than the water supplied by Columbia Water & Light. If a person wants to check lead levels at their building, there are several labs in the area that do lead testing for water. As a public entity, Columbia Water & Light cannot endorse any private lab to do the lead testing.

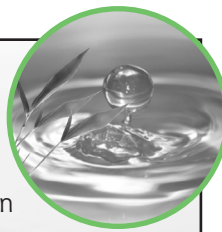

Summer changes to water disinfection

During the summer months, the Department of Natural Resources recommends Columbia Water & Light switch from the chloramine (chlorine plus ammonia) to the chlorine disinfection process. Switching to chlorine reduces nitrification caused by the chloramine disinfection method.

Customers might notice more of a chlorine taste and smell until the fall when the disinfection method is changed back to chloramine disinfection. Customers who are sensitive to the chlorine taste can fill a pitcher with water and wait for several hours to drink it. Activated carbon filters will also reduce the chlorine taste. Customers using filters are urged to replace filters as recommended by the manufacturer to reduce the risk of harmful microorganisms forming.

There are many types of disinfection processes that can be used for water. Each has their own pros and cons. Some methods can be very costly and don't guarantee that the water will continue to be safe all the way from the treatment plant to the customer's faucet. The chlorine/chloramine disinfection methods are the best way to make sure the water stays disinfected through the entire water system.

Connecting [with] Cops



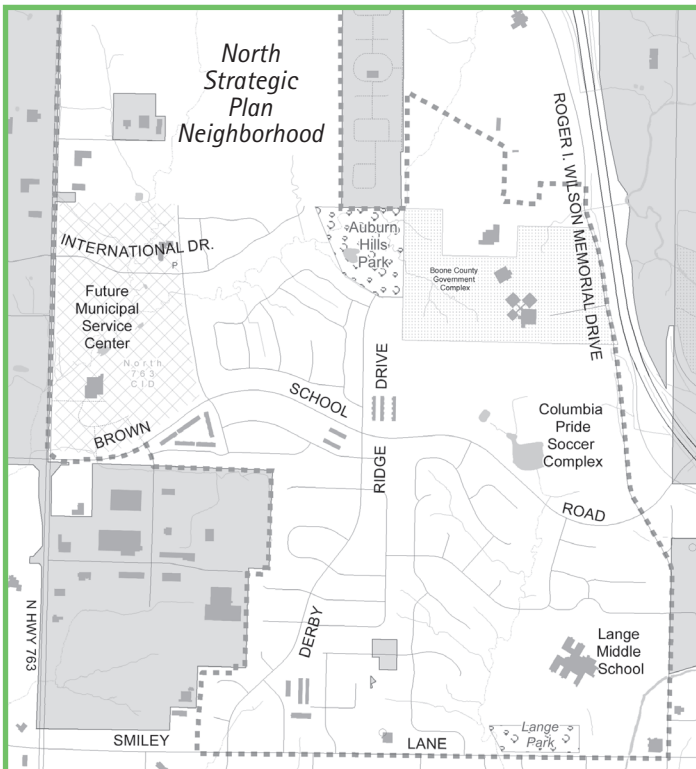
Officers Scott Lenger (left) and Tony Parker are assigned to the Strategic Plan's north focus neighborhood in CPD's Community Outreach Unit.

Strategic Plan—Contact Center

As part of the 2012-2015 Strategic Plan, the Contact Center was developed to eventually provide citizens with a one-call resolution for City services. The Contact Center began taking calls for Solid Waste in April 2014, and has since added phone numbers for Public Works and part of City Utilities. As part of the Operational Excellence strategic priority in the current 2016-2019 Strategic Plan, the City will increase the percentage of citizens who know who to contact for City services by 6 percent by 2019 with the public launch of the Contact Center telephone number by 2018 and the development of a citywide communication plan. Operation Clean Streets visits Indian Hills

The City's third Operation Clean Streets event visited the Indian Hills neighborhood and park on Friday, April 22. Participants also worked in Indian Hills Park on painting projects and mulching the disc golf course.

Operation Clean Streets has been held in the spring and fall to allow City staff to have a special work day on City streets. The Indian Hills area was selected as it is in the City's east Strategic Plan focus neighborhood.

New utility billing software

Utility Customer Service (UCS) continues to work on implementing the new billing software. UCS did not feel the software was ready to go live in May and a future date has yet to be determined. UCS anticipates mid-summer depending on system functionality. When a firm date for the conversion is determined information will be released to the public. When the date is set to go live the Utility Customer Service lobbies will be closed temporarily. Every effort will be made to let customers know of those closures. The majority of meter reading cycle changes have been completed so please check to see if you have a new bill due date. UCS still plans to mail letters to each customer prior to the software conversion. Again, UCS thanks you in advance for your continued patience as we work through this billing software change.

Cleanup Columbia a success

The City's single largest volunteer event was held on Saturday, April 9 with the annual Cleanup Columbia, a city-wide trash pickup event. Volunteer Programs staff, who organized the event, report that 1,419 volunteers picked up litter in more than 130 locations, logging 2,631 hours of service and picking up 1,622 bags of trash.

There isn't a requirement to get a building permit to construct a fence, however, fences are considered an accessory structure that "shall be maintained structurally sound and in good repair." Fences should also not be constructed in the right of way and not cause a sight obstruction for traffic.

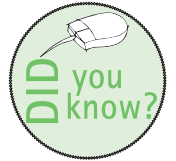
