Checklist

- PAID RECEIPT:** This application must be submitted with a copy of the paid receipt for the unit. The receipt must list the model numbers for the condenser, evaporator coil and any furnace or air handler listed in the AHRI directory.
- PERMITS:** A copy of the final mechanical permit from the City of Columbia Protective Inspection Division of Public Works must be submitted along with the application. These permits are usually obtained by the contractor.
- SIZING:** Columbia Water & Light reserves the right to deny a rebate for a unit that is oversized for a building. Either your contractor or the utility can help you with purchasing a properly sized air conditioning system.
- DEADLINES:** The rebate application form and receipts must be submitted to Columbia Water & Light within six months of the air conditioner unit's installation. Incomplete or incorrect applications will have thirty days to provide the correct information or risk losing their place in the rebate funding process.
- VERIFICATION:** Columbia Water & Light reserves the right to inspect the installed equipment before the rebate payment is issued.
