MUNICIPAL COURT OPERATING ORDER #2
EFFECTIVE DATE: JANUARY 1, 2009

The Court, on its own motion, makes the following General Orders with respect to the administration of the Court:

1. Kevin R. Oeth is hereby appointed the Probation Officer for the 13th Judicial Circuit Court Municipal Division for the City of Columbia, Missouri for the purposes set forth in **Missouri Revised Statute** Section 559.607.1 (2005).

2. Kevin R. Oeth shall remain an employee of the City of Columbia, Missouri for all administrative and employment purposes.

3. Pursuant to the authority granted by **Missouri Revised Statute** Sections 559.604 and 559.607.1 (2005), all persons found guilty or pleading guilty to ordinance violations within the City of Columbia, Missouri and placed on probation by a Municipal Court Judge shall contribute a service fee to the court in an amount of thirty (30) dollars per month to pay the cost of their probation supervision provided by a probation officer employed by the City of Columbia, Missouri and assigned to the City of Columbia Municipal Division of the 13th Judicial Circuit of Missouri.

4. The defendant shall pay this service fee at the time the defendant is placed on probation by the Municipal Court Judge as follows:


a. The first thirty (30) dollar court service fee payment shall be made at the time the defendant is placed on probation by the Municipal Court Judge. Failure to pay this fee as ordered by the court will be grounds for a probation violation hearing.

b. The Court will exercise its authority to exempt the service fee ordered in paragraph 3 above for all probationers who comply with the conditions of their probation without necessitating further work by the probation officer after they have paid the first court service fee payment required in 4(a) above.

c. If the probationer does not comply with their order of probation and therefore requires the court probation officer to take further action in the defendant's case, such as issuing probation violation hearing notices, appearing at probation violation hearings, preparing arrest warrants, etc. the defendant will be ordered to pay the thirty (30) dollar court service fee for every month in which the Court's probation officer is required to take some action in the defendant's court case.

5. The Municipal Division Court Clerk is hereby ordered to provide a copy of this order to the Missouri Board of Probation and Parole as required by law. The Municipal Division Court Clerk is also ordered to send a copy of this order to members of the Missouri Bar who regularly appear in this court and she is to post a copy of this order on the City of Columbia Website and on the bulletin board outside of the George F. Nickolaus Courtroom 600 East Broadway Columbia, Missouri.
