The City of Columbia received four (4) separate valid citizen complaints about mask order violations at this business. These were received on July 22, 2020; July 31, 2020; August 21, 2020; and September 14, 2020, respectively.

SINCE WE HAVE RECEIVED 3 COMPLAINTS ABOUT THIS BUSINESS AND I HAVE ALREADY FORWARDED A VIOLATION TO ROBERT FOR PROSECUTION, I AM FORWARDING OVER A HARD COPY OF THIS COMPLAINT SO THAT HE CAN UTILIZE IT IN THE ALREADY EXISTING CASE.

I PERFORMED AN ON SITE INSPECTION AND OBSERVED THAT CAROL ANN WAS WEARING A MASK BUT NOT COVERING HER NOSE, IT CONTINUED TO FALL BELOW HER MOUTH AND SHE WOULD HAVE TO PICK IT BACK UP. I ASKED FOR THE MANAGER ON DUTY, NOT WEARING A NAME TAG, AND SHE CAME OUT AND SPOKE WITH ME, SHE WAS ALSO NOT WEARING A MASK. SHE TOLD ME TO CONTACT THEIR MANAGER KYLE GREENWELL AT 636-220-3800. I CALLED AND WAS TOLD THAT HE WAS OUT OF THE OFFICE. I LEFT A MESSAGE WITH THE ADMINISTRATIVE ASSISTANT AND ASKED FOR A CALL BACK. FORWARDING TO PROSECUTION.


I PERFORMED AN ON SITE INSPECTION, AND OBSERVED CAROL ANN NOT WEARING HER MASK PROPERLY. I ASKED FOR THE MANAGER ON DUTY AND SHE CAME OUT TO ME, NOT WEARING A MASK AND GAVE ME KYLE GREENWELL, HER MANAGER. I CALLED KYLE AND LEFT A MESSAGE WITH HIS ADMINISTRATIVE PROFESSIONAL. KYLE CALLED ME BACK AND WE HAD A DISCUSSION ABOUT THIS LOCATION AND THE EMPLOYEES NOT WEARING A MASK, HE SAYS THAT SHE HAS A MEDICAL EXEMPTION. I ADVISED HIM OF ACTIONS I HAD SEEN HER TAKE IN PAST VISITS AS WELL AS WHAT WE WERE HEARING FROM THE CUSTOMERS IN THEIR COMPLAINTS TO US. HE SAYS THAT HE WILL AGAIN HAVE A CONVERSATION WITH THE MANAGERS OF ALL THREE COMO LOCATIONS AND TO ADVISE THAT THEY ALL NEED TO BE WEARING MASKS PROPERLY AND TREATING THEIR CUSTOMERS WITH RESPECT, AND TO NOT MAKE THE ISSUE POLITICAL. HE ALSO ADVISED THAT HE IS GOING TO HAVE CHRISTINA ANDERSON, WHO IS THE DIRECTOR OF HUMAN RESOURCES AND HANDLING AND HANDLING ORDINANCES GIVE ME A CALL I ADVISED THAT I WAS GOING TO SEND THIS OVER TO OUR PROSECUTING ATTORNEY FOR FURTHER ACTION DUE TO EMPLOYEES NOT WEARING MASKS EVEN AFTER A COMPLAINT WAS SENT OVER TO THE PROSECUTING ATTORNEY ALREADY.

KRISTINA ANDERSON CALLED ME THIS AFTERNOON AND WE SPOKE ABOUT THE COMPLAINTS OUR OFFICE HAS RECEIVED AND MY OBSERVATIONS AS WELL. I DID ADVISE THAT DUE TO THE FACT THAT WE CONTINUE TO GET COMPLAINTS COUPLED WITH MY OBSERVATIONS OF MASK ORDINANCE VIOLATION, I AM FORWARDING THIS TO THE PROSECUTOR FOR FURTHER ACTION. I SENT HER A COPY OF THE COMPLAINTS WE HAVE RECEIVED AND SHE VERBALLY EXPRESSED DISAPPOINTMENT AND SURPRISE AND TOLD ME SHE WOULD BE DRIVING TO COLUMBIA TODAY TO HAVE CONVERSATIONS WITH THE MANAGEMENT. SHE GAVE ME HER COMPLETE CONTACT INFORMATION AND WE AGREED THAT IF ANY ADDITIONAL COMPLAINTS CAME IN THAT I WOULD GIVE HER A CALL OR EMAIL TO LET HER KNOW.

In each of these visits, there have been multiple employees not wearing masks among the what seems to be more than half of customers consistently refusing to wear masks, and the store not enforcing the ordinance. Today, 7/21, there were 4 visible employees in the store, two of which were not wearing masks, and one of those two being the store manager! This blatant disregard for public health is appalling, and should warrant disciplinary action."

When he told the cashier, the person responded that they are not allowed to enforce it. Later he went in and saw three out of fifteen customers without masks, and the cashier had their mask on their chin, not covering their mouth or nose.
