A. Historic Preservation Plan Table of Contents (Draft)

Commissioner Ohnersorgen arrives at 5:45 p.m.

Commissioners discussed the commonalities between the different historic preservation plans that were submitted at the last work session. It was agreed that the proposed table of contents by staff would act as the basis for structuring the City's Historic Preservation Plan; however, make be modified and/or expanded as the future plan takes shape. It was further discussed that the Commissioners may want to volunteer to engage in researching and collecting informtion on a specific topic area that could be reported out to the other Commissioner's at a future meeting. Collecting and preparing this information would be benifical for future use with a possible consultant.

Mr. Zenner reiterated to the Commissioners that collecting data on the topic areas could be used to help augment the content on Historic Preservation that is contained within the City's Comprehensive Plan. He further noted that the preparation of the Historic Preservation Plan is a good use of the Commission's time, but is not essential for the City to maintain its existing CLG status.

Commissioners discussed potential methods for gathering more public input on the content of the Plan by utilizing City Source as an outreach tool for HPC survey. They also discussed creating a small HPC work group to review public input from the prior public meeting held last spring and to report on this input at the April HPC regular meeting.

B. Historic Preservation Plan Goals - Discussion/Scoping

Commissioner's further discussed potential plan goals and possibilities such as creating/utilizing a GIS Story/History Maps similar to what the Missouri State Parks is currently doing; enhancing transparency and access to local historical data on Columbia buildings, structures, spaces, corridors (on a website or on a GIS map); identifying historical districts within Columbia and making them more visible; increasing education and outreach to the general public; bringing in the knowledge and talents of other local groups such as the African American Heritage Trail Commission to augment the HPC's efforts in telling the history of Columbia, and looking to the HPC's establishing ordinance as a framework for additional goals.

It was agreed that each Commissioner would put together a list of their goals for the Preservation Plan that could be shared with the rest of the Commissioners at the next work session or regular meeting.
