On 02/17/14 at approximately 11:40 hours, I received a return phone call from Meghan ANDERSON. Ms ANDERSON is currently the Academic Coordinator at the University of Tennessee. Ms ANDERSON was formerly at the University of Missouri as the Assistant Director of Academic Services. Ms ANDERSON was at the University of Missouri during the time in which Sash MENU-COUREY was enrolled and dealt with MENU-COUREY on a regular basis.

In speaking with Ms ANDERSON, she advised she was Sasha's main advisor during her time at Mizzou. I explained to Ms ANDERSON that I was currently conducting an investigation into an alleged sexual assault that was discovered after Sasha MENU-COUREY committed suicide. I explained to her that while going through a journal entry from May of 2011, Sasha indicated that she contacted Ms ANDERSON by phone and disclosed to her that she had been sexually assaulted while she was a student at Mizzou.

Ms ANDERSON advised that she did recall receiving a call from Sasha while Sasha was in Boston. Ms ANDERSON advised that she remembered being out at a restaurant with a friend and taking the call. She stated she talked briefly with Sasha about her academic eligibility at Mizzou and explained to her that she would certainly be academically eligible to return. She stated that during this conversation, she did tell Sasha that given her current situation, that there would be other factors involved that she would need to attend to as well. Ms ANDERSON advised that the conversation did not last very long and at no point did Sasha ever disclose to her that she had been sexually assaulted. I asked Ms ANDERSON if, at any time while she was Sasha's advisor, Sasha indicated to her that she had been the victim of a sexual assault. Ms ANDERSON advised Sasha never made any statements indicating she had ever been sexually assaulted.

Ms. ANDERSON went on to say that she was, "shocked," when she saw Melissa JAMERSON interviewed for the Outside the Lines Story. She said that she was unaware that Sasha and Melissa were close friends. Ms. ANDERSON stated that since the story, she had been contacted by some of Sasha's friends/teammates and was told by them that they were never told anything by Sasha that lead them to believe that she had been the victim of a sexual assault. Ms. ANDERSON stated that she believed that Caitlin CONNER, Joe HLADIK, and Ashley PATTERSON were some of Sasha's good friends. After we ended our conversation, Ms. ANDERSON sent to me an email with phone numbers for these individuals.

This report should be considered a summary of my contact with Meghan ANDERSON. Our conversation was recorded and placed onto a compact disc so the conversation can be heard in it's entirety. This compact disc was placed into evidence at the Columbia Police Dept.

In speaking with WOODLAND, I asked him if he was able to locate a letter that we had discussed in our previous interview. He advised that he was attempting to locate the letter and would provide it to me as soon as he could get it from his mother.

I went on to ask WOODLAND if he could clarify some information for me. I explained to him that during our interview, he stated that Laroderick THOMAS was in the room the night that Sasha MENU-COUREY was allegedly sexually assaulted. I asked him how he knew this. He stated that Sasha wrote that information in the letter she sent to him shortly before she died.

I also asked him if he had been able to contact Melissa JAMERSON, as I had no success in contacting her. He stated he did contact Melissa via Facebook but she stated that she did not want to get involved.

On 04/03/14 at approximately 14:47 hours, I made telephone contact with Gilbert MOYE. I advised MOYE that I wished to speak with him about his relationship with Sasha MENU-COUREY. MOYE advised he and Sasha were good friends. He advised that whenever they both started becoming intimately involved, she was seeing a guy on the football team and he was also in a relationship with another person. He stated they started seeing each other and having a sexual relationship. He stated his lawyer advised him he probably shouldn't talk, but he wanted to clear his name.

MOYE advised the incident in question occurred when he and Sasha went out one night in either March of 2010 or 2011. He advised he could remember it was in the spring time for sure. He stated he also remembered it was during a time when he had quit the football team because his mother was ill. He stated they went out and got drunk and it was just the two of them together at his apartment and they had sex.

He stated they were getting ready to lie down after they had sex and he observed Laroderick THOMAS leaving his room when Sasha lied down next to him and was crying. He advised the room was pitch black but he saw Laroderick THOMAS exit the room. He stated she was crying at the foot of the bed.

MOYE went on to state Sasha asked him how he could let him (THOMAS) do that. He advised he did not realize THOMAS had done anything until Sasha made that remark. MOYE said that whatever happened, occurred within a matter of seconds. I asked him if there was any video of this incident. He stated he had no knowledge of any video. MOYE advised he knew Rolandis WOODLAND had made reference to three guys in a video with Sasha but he has no knowledge of any video being taken of this incident.

I asked MOYE if he could be more specific about this incident. He stated on the night of this incident, he picked Sasha up at around 9 or 10 PM. He stated they first went to the Big 12 and then to the Field House. MOYE said they stayed at the Field House until it closed. He stated they left

there, and on their way back to his place, he dropped off a couple of friends at their residences and then went home.

He advised once they got to his place, they went to his bedroom and they had sex. I asked him if he could tell me what they had been drinking that night. He stated he had a couple of shots and a couple of beers. He advised he was not exactly sure what Sasha had been drinking because although they arrived together at both the Big 12 and Field House, they would separate for a time and mingled with friends. MOYE said they were not in direct sight of one another throughout the vast majority of the evening.

I asked MOYE if he could tell me what happened after they had sex. He advised he put his shorts on, got into bed, and closed his eyes. He advised after he had closed his eyes was apparently when something happened to Sasha. He advised when he was lying down, she was standing at the foot of the bed and was cleaning herself up. He said there was a towel hanging there that she was using, as there was not a bathroom attached to his bedroom. He said she did not leave the room. MOYE also said he was certain that he locked his door when they entered the room.

MOYE stated the next thing he knew, Sasha was lying down next to him, crying, and asking him how he could betray her. He stated they talked about it briefly. He said he didn't know anything happened. MOYE said they fell asleep and they never said anything about it again. MOYE stated it was after Sasha was lying down and she asked him how he could have betrayed her, he observed Laroderick THOMAS leaving the room.

I asked him if there was anyone else home that evening when they arrived from going out. He advised there was not. He stated he did not know when Laroderick THOMAS arrived back at their place. I asked him who his roommates were at the time. He named Laroderick THOMAS, Sean WHITHERSPOON, and Justin GARRETT.

I asked him if he could provide for me a good working phone number for Laroderick THOMAS. MOYE provided me with that number and said THOMAS was currently living in the Dallas, Texas area.

stated that he has walked in other friends, but never Gil and Sasha.

Laroderick stated at his residence, there were a lot of parties that occurred there. He advised there were many people coming in and out of thier apartment all of the time. I asked him if at any point he had ever made any kind of sexual advances or even suggested to Sasha that they have sexual intercourse. He advised he has never had sex with Sasha nor has he ever attempted to have sex with Sasha.

This report should be considered a summary of my interview of Laroderick THOMAS. The interview was recorded on a compact disc and the disc secured in evidence at the Columbia Police Dept. so the interview can be heard in it's entirety.

On 08/04/14 at approximately 07:30 hours, I went to 1225 Fellows Place, the Hampton Inn, to meet with Lynn COUREY, the mother of Sasha MENU-COUREY.

Upon arrival, I met with Ms. COUREY in the lobby area of the hotel. In contacting her, she provided to me a Blackberry Tour cellular telephone, black in color, and an Apple laptop computer, gray in color. Ms. COUREY advised that both of these articles belonged to her daughter prior to her death. Ms. COUREY explained the Apple laptop had been sent back from a facility in Boston to her home after Sasha committed suicide in 2011. She advised that no other entity outside of her home had any access to this computer. She advised, however, that the Blackberry cellular phone had been in the possession of ESPN for several months.

I advised Ms. COUREY that I would download the Blackberry phone personally and take the laptop computer to the Boone County Sheriff's Dept. Cyber Crimes Unit for them to download and analyze. I then provided Ms. COUREY with a receipt and had her complete a Consent to Search Form for the laptop computer and the Blackberry.

I then went to the Boone County Sheriff's Dept. and made contact with Cyber Crimes Unit Detective Cody Bounds. I provided him with the laptop computer at approximately 08:15 hours.

I then returned to the Columbia Police Dept. and, using the Susteen Secure View 3 software on my computer, conducted a download of the Blackberry device. I completed my download at approximately 11:24 hours.

At approximately 13:45 hours, I was in contact again with Detective Bounds of the Boone County Sheriff's Dept. I retrieved from him the Apple laptop computer. Detective Bounds advised he would analyze the raw data that

was extracted from the computer and attempt to locate the video files in question along with the journal entries. He advised this could take him several seeks to complete given his current case load.

After ending my contact with Detective Bounds, I made telephone contact with Lynn COUREY and advised her that I was able to return the Blackberry computer and the Apple laptop computer to her. Ms. COUREY advised she was not at her hotel and was using public transportation and was on a bus within the city limits of Columbia. She advised that it would be best if I attempted to make contact with her first thing on 08/05/14, to return the items. I advised her I would check into service at 08:00 hours and immediately respond to the Hampton Inn. I then took the Apple laptop computer and the Blackberry device to the Columbia Police Dept. and secured them in my office in a locked file cabinet.

On 08/05/14 at approximately 08:30 hours, I made contact with Ms. COUREY at the Hampton Inn. At that time, I returned to her the Blackberry cellular phone, and the Apple laptop computer.

I then returned to the Columbia Police Dept and analyzed the material contained within the cellular phone. While going through the contents of the phone, I did observe several photographs that were pornographic in nature. I was not able to locate a video of any type of sexual activity.

There was one message on the cellular phone that indicated that Sasha had been the victim of a sexual assault. This is message #16 in her outgoing messages in the "Message 1" file. The date/time of the message was 03/22/2011 at 00:35 hours. This message was sent to an individual identified as Gidget BROWN and stated, "My whole life is over I gave it all all my whole soul my hole heart I went all in... After quies and a rape I still got vulnerable & gave it all to mag.."

The cellular phone data from the Blackberry device was copied onto a DVD and secured in evidence.


