Summary: The Department of Parks and Recreation is requesting Council action to appropriate \$12,171 to the Flat Branch Park Phase II development project from funds received from a DNR storm water grant draw down for Flat Branch Park Phase I and appropriate \$5,623 to the Stephens Lake Park development project from funds donated for the project.

Discussion:

When Flat Branch Park Phase I (4th Street to Locust St.) was completed, the project fund balance was transferred to the Flat Branch Phase II development project. The final DNR storm water grant drawdown in the amount of \$12,171 for Flat Branch Park Phase I was received after the project was closed, and therefore was not included in the fund transfer to the Flat Branch Park Phase II development project.
