

A RESOLUTION

declaring the necessity for construction of improvements at Nifong Park, Valley View Park and Hickman Pool; stating the nature of and the estimate of the cost thereof; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems that the construction of improvements at Nifong Park, Valley View Park and Hickman Pool, to include:

Nifong Park:

1. Construction of a 12-foot wide gravel walkway down the center of the Nifong Park Historical Village connecting to an existing walkway at the Nifong Park Animal Barn.
2. Improvements to Nifong Park Lake by relocating the lake dam farther south and dredging the existing lake bed and using the soil to level several low areas in the park.
3. Installing park security lighting at various points throughout the Nifong Park Historical Village.

Valley View Park:

1. Replacing specific gravel sections of trail with concrete.

Hickman Pool:

1. Replacing an existing wooden sign with an aluminum sign.

are necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvements shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 3. The estimated cost of the improvements is \$55,000.00.

SECTION 4. Payment for the improvements shall be made from Park Sales Tax Funds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvements specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.

SECTION 6. This resolution shall be published in a daily newspaper of general circulation in the City of Columbia for seven (7) consecutive insertions, and a public hearing in respect to this improvement will be held in the Council Chamber of the Daniel Boone Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on March 5, 2007.

COUNCIL SUMMARY

The resolution setting the public hearing related to this item was required to be published in a daily newspaper of general circulation in the City of Columbia for seven (7) consecutive insertions, which would have been February 11, 12, 13, 14, 15, 16 and 18, 2007.

The resolution was published in the Columbia Missourian on February 11, 12 and 13, 2007 showing the public hearing at February 19, 2007. However, the Columbia Missourian failed to publish the resolution (R24-07) on Wednesday, February 14, 2007, and therefore, we were unable to meet the seven (7) consecutive insertions requirement by the date of the public hearing – February 19, 2007.
