Council Bill No. B 70-09

AN ORDINANCE

determining it is in the public interest to construct improvements at A. Perry Philips Park Phase I; approving and adopting plans and specifications; determining that the work shall be done by contract; calling for bids through the Purchasing Division; determining that a portion of the work shall be done by City employees; providing for payment for the improvement; authorizing the City Manager to obtain, execute and record all documents necessary for the improvement; providing for compliance with the prevailing wage law; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council adopted a resolution declaring the necessity of constructing improvements at A. Perry Philips Park Phase I; and

WHEREAS, the resolution was published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held a public hearing on construction of the improvements.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds that the construction of improvements at A. Perry Philips Park Phase I, specifically the construction of an entrance road, parking lot, boat ramp, courtesy boat dock, floating fishing dock, restroom, security lighting, sidewalks and a lake perimeter trail, in the City of Columbia, Missouri, is necessary for the welfare and improvement of the city and that it is in the public interest that such improvements be made.

SECTION 2. The plans and specifications for this improvement, as prepared by the Director of Parks and Recreation and filed in the office of the City Clerk, are hereby approved and made a part of this ordinance by reference.

SECTION 3. The construction of the improvement shall be done by contract in accordance with the plans and specifications, the laws of the State of Missouri, and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 4. The City Manager, through the head of the purchasing division, is hereby authorized to call for bids and award contracts for construction of the entrance road, boat ramp, courtesy boat dock, floating fishing dock, parking lot, walkways, lighting, trail grading and installation of the restroom. As deemed advisable by the City Manager, City employees shall be used for final trail construction and landscaping.

SECTION 5. Payment for this improvement shall be made from Park Sales Tax Funds, a Missouri Department of Conservation Grant and such other funds as may be lawfully appropriated.

SECTION 6. The City Manager is authorized to obtain, execute and have recorded all licenses, easements, deeds and any other conveyances or instruments necessary for the City to complete this improvement.

SECTION 7. The contract for the improvement shall provide that not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under the contract. The contractor's bond shall guarantee the faithful performance of the prevailing hourly wage clause in the contract.

SECTION 8. This ordinance shall be in full force and effect from and after its passage.

EXECUTIVE SUMMARY:

The Department of Parks and Recreation is requesting authorization to proceed with improvements to A. Perry Philips Park as approved in the City's FY-07 CIP budget. The project will consist of the construction of passive, natural resource based facilities such as a fishing/boat dock, boat ramp, walking trail and support amenities including a small restroom and parking lot. Total project cost is \$407,500 with \$250,000 coming from the Park Sales Tax and \$157,500 from a grant received from the Missouri Department of Conservation. Construction is scheduled to begin during the 2009 construction season by a combination of park staff and contract labor.

DISCUSSION:

The Department of Parks and Recreation is requesting approval to proceed with improvements to the A. Perry Philips Park including the construction of passive, natural resource based recreational amenities. As approved and funded by the 2005 Park Sales Tax, the department has \$250,000 for Phase I development of the Philips Lake Park. Additionally, the City has received a \$157,500 Missouri Department of Conservation (MDC) grant to construct fishing facilities at Philips Park. The City's match for the grant is \$52,500, funded out of the Phase I

park development budget. The following amenities are to be constructed as part of the grant agreement: entrance road, parking lot (minimum 10 vehicles + 10 vehicles w/trailer), boat ramp, courtesy boat dock, floating fishing dock, restrooms, security lighting, and sidewalks connecting facilities. In addition to these grant funded facilities, the department anticipates that a lake perimeter trail will be constructed as well.

Park planning staff is in the process of completing the final master plan for the Philips Park and the Gans Creek Recreation Area. Together, these two parcels represent a 460 acre Southeast Regional Park. The construction of these natural resource based facilities will not impact the Southeast Regional Park planning process. The department has prepared two options for the public to consider and the MDC funded facilities are similarly shown in the same scale and location on both options. Staff from the Missouri Dept of Conservation, Missouri Department of Natural Resources and the P&R Department have inspected the site and together, believe that these facilities are sized and located in the best location for a phased development plan. The development of a Southeast Regional Park is an identified project in the *Parks, Recreation, and Open Space Master Plan*.

Philips Park has both C-P and O-P zoning. On February 5, 2009, the Planning and Zoning Commission voted unanimously to approve the Philips Phase I PUD development plan. The ordinance approving the PUD development plan was introduced to Council on February 16, 2009 and was approved by Council on March 2, 2009.

Construction is scheduled to begin this summer. The majority of the work will be done by contract labor including the construction of the boat and fishing docks, boat ramp, parking lot, walkways, lighting, trail grading and installation of the restroom. Park staff will be used for final trail construction and landscaping. Park staff may purchase the prefabricated restroom if it becomes available through a state or regional purchasing pool. Once a contractor price is determined, any remaining Phase I development funds will be used to begin park development as so directed by those priorities identified during the park master plan process. Staff anticipates that these priorities may include passive recreation features such as a picnic shelter, playground and related support amenities (walkways, drinking fountains, landscape, etc.). The scope of these additional features will be based on available funding.

FISCAL IMPACT:

The Philips Phase I project is included in the City's FY-07 capital improvement budget with a total project cost of \$407,000 including funding in the amount of \$250,000 from the 2005 1/8-cent Park Sales Tax and \$157,500 in grant funds from the Missouri Department of Conservation.


It is recommended that the department's FY-2010 annual operating budget be considered for an increase of \$9,845 including \$7,715 in temporary salaries, \$1,500 in utilities and \$630 in materials and supplies to address the maintenance needs of the new facilities. At this time, the department is not requesting any permanent employees based on the addition of this park, but as other parks are added or developed, the conversion of temporary salaries to permanent may be requested. If the department's operations budget does not increase, additional measures such as deferred maintenance, reduced levels of care, or other cost saving measures may need to be implemented to meet ongoing maintenance needs of the park system.

It should be noted that the estimated 2 year net costs are solely for operation and maintenance expenditures only. The Department has indicated that it is likely as the proposed improvements are brought on-line there may be occasion for special events to occur at the developed facilities. Such activities or events may require additional staff support or maintenance to be performed to accommodate such events (i.e. a fishing derby). It is believed that the additional service costs may be fully or partially off-set by special event or registration fees.



SUGGESTED COUNCIL ACTIONS:




A. Perry Philips Park & Gans Creek Recreation Area Proposed Master Plan - Option 1
