RIGHT OF USE PERMIT

(\$10.00) and other considerations to it paid, does hereby pe	rmit LAST Enterprises	LLC (Owner),
their heirs and/or assigns (hereinafter referred to as "Permi	ittee") to enter upon the	following
described lands owned by the City of Columbia and locate	d within the right of wa	y at approximately
105 S. 8th Street (building address at 800 Cherry), Columbia	i, County of Boone, Sta	ite of Missouri, and
more particularly described as follows, to wit:		

An egress ramp w/handrail in the right of way at the Southeast corner of Cherry and S. 8th Street, extending along west property boundary of lot 105 as needed for said ramp and landing per attached diagram.

This permit is subject to the following conditions and stipulations:


- 1. This permit is for the exclusive purpose of construction, improvement, operation and maintenance of an egress ramp in a portion of the right of way of S. Eighth Street. The City consents and understands that Bank of America is going to participate in the operation, maintenance and construction egress ramp improvement.
- 2. This permit does not grant Permittee or any of its officers, agents or employees, including Bank of America, the right to cut, break, excavate or damage the street pavement of S. Eighth Street without City of Columbia consent.
- 3. Permittee will be responsible for the costs of any future repairs, maintenance or replacements which is the result from Permittee's use under this Right of Use Permit.
- 4. Prior to exercising its right granted herein, the Permittee shall present construction plans or diagrams locating the proposed infrastructure to the City Public Works Department and City Water and Light Department and any existing utility company using facilities located within the limits of the Permit.
- 5. Prior to exercising its right granted hereunder, Permittee agrees to obtain all necessary permits required by the City of Columbia pertaining to work being done in the right of way.
- 6. If the ramp and/or handrail is ever abandoned, all rights herein granted shall cease and terminate and Permittee shall have no further right of interest therein except that, upon abandonment, Permittee remains responsible for all of Permittee's facilities and structures left in place and any costs to remove them or store them or to otherwise clean up easement.
- 7. If at any time during construction, repair, modification or relocation of the ramp and/or handrail, or any utility existing in the easement at the time this permit is granted, is necessary which would require the relocation of the ramp and/or handrail, the Permittee shall relocate the ramp and/or handrail at their own expense.
- 8. The Permittee agrees by exercising its rights under this permit that if the ramp and/or handrail becomes damaged in anyway, whether negligently or intentionally by the construction, repair, modification or relocation of any utility existing in the easement at the time this permit is granted it will repair or replace the ramp and/or handrail at their own cost and hold the City of Columbia harmless for any of the costs associated with the repair or replacement or any other costs associated with the damage to the facilities.
- 9. This permit shall remain in effect until canceled by the City of Columbia, which shall be obligated to notify the Permittee six (6) months in advance of cancellation.






