Transfer of Funds for Signal Improvements to the intersection of Green Meadows Road and Grindstone Re: Plaza Shopping Center

### EXECUTIVE SUMMARY:

Staff has prepared for Council consideration a resolution authorizing a transfer of funds from a Fiscal Year 2013 supplemental budget account to a capital improvement project account for signal improvements to the intersection of Green Meadows Road and Grindstone Plaza shopping center.

### DISCUSSION:

A supplemental budget item, in the amount of \$80,000, was approved in Fiscal Year 2013 for signal improvements to the intersection of Green Meadows Road and Grindstone Plaza shopping center (at Wal-Mart and Kohls). The planned improvements include flashing yellow arrows for left turns, additional detection for bicycles, and fiber optic communications with the signal at Grindstone Parkway and Green Meadows Road. Some design work is needed to implement the project, making it difficult to complete in just one year. In order to move forward with the improvements, the supplemental funds will need to be transferred to a capital improvement project account. The improvements are planned for FY2014.

### FISCAL IMPACT:

Funds in the amount of \$80,000 are being transferred from Traffic Control supplemental budget account to a capital improvement project account.


Dedicate funds to identify routes and corridors for all modes, preserve rights of way, and improve existing intersections to enhance safety and improve capacity.
