Council Bill No. B 279-13

AN ORDINANCE

declaring it is in the public interest to proceed with replacement of a water main along Business Loop 70, between Old Highway 63 and Eastwood Circle; directing that plans and specifications for the improvement be prepared; declaring the necessity for the acquisition of easements; providing for payment for the improvement; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council adopted a resolution declaring the necessity of replacing a 12-inch water main along Business Loop 70, between Old Highway 63 and Eastwood Circle; and

WHEREAS, the notice of a public hearing on this project was published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held a public hearing on construction of the improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds and determines that replacement of a 12-inch water main along Business Loop 70, between Old Highway 63 and Eastwood Circle, is necessary for the welfare and improvement of the City and that it is in the public interest that such improvement be made.

SECTION 2. The route and general location for the construction of such improvement, as attached hereto in Diagram A, is hereby approved and the City Manager is directed to have plans and specifications prepared.

SECTION 3. The acquisition of easements by negotiation for construction of such improvement is deemed necessary and is hereby authorized and the City Manager is further authorized to execute and record all such easements, deeds and other instruments deemed necessary for construction of such improvement.

SECTION 4. Payment for this improvement shall be made from Water and Electric System revenue bonds appropriated in Capital Improvement Project No. WT0197, and such other funds as may be lawfully appropriated.

SECTION 5. This ordinance shall be in full force and effect from and after its passage.

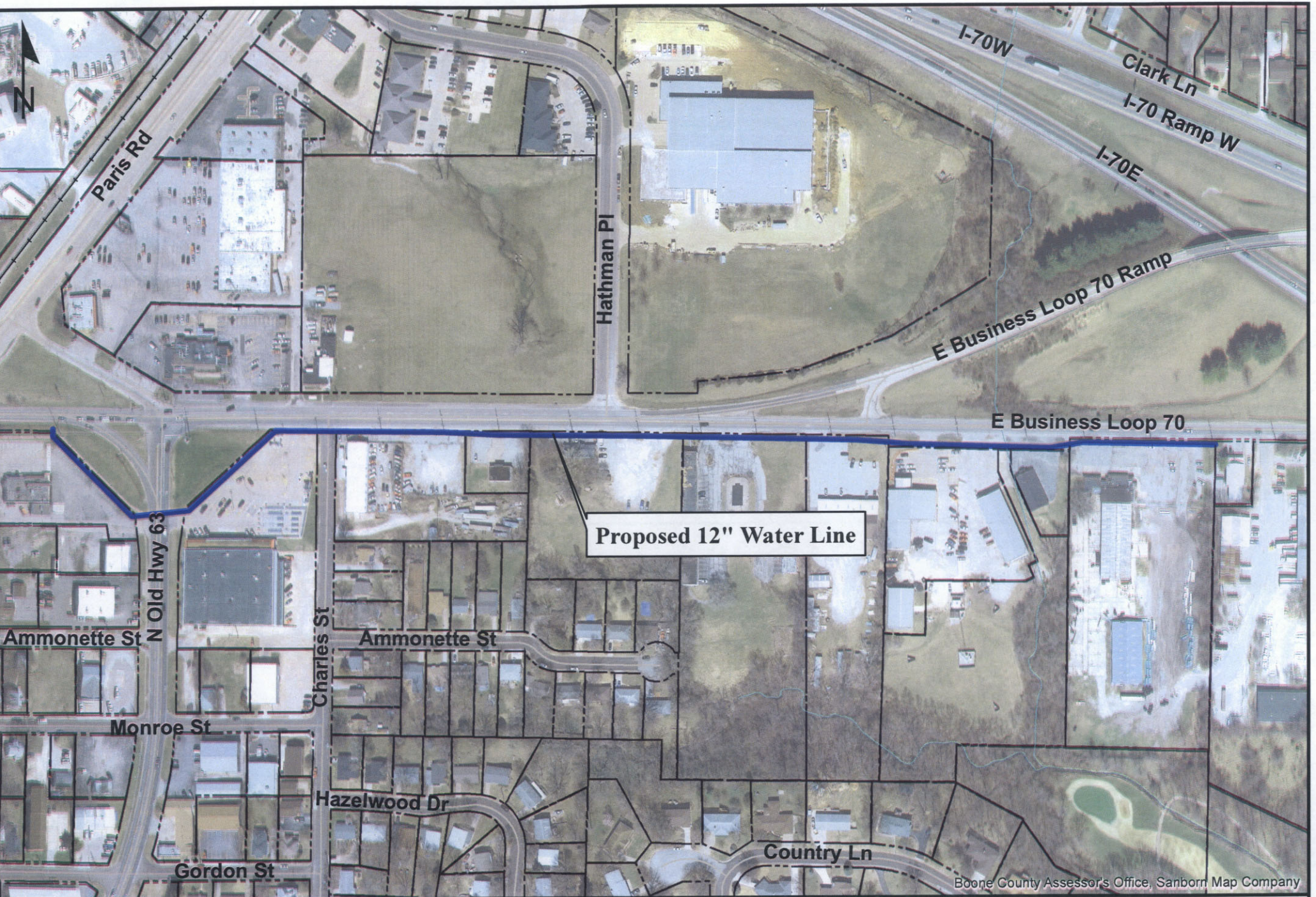

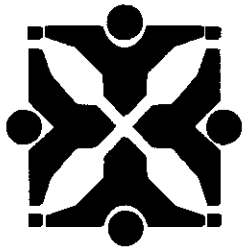


Proposed 12" Water Line Alignment

Re: Business Loop Water Main Replacement Project - Phase 6b

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration an ordinance to proceed with replacement of a water main along Business Loop 70, between Old Highway 63 and Eastwood Circle.

DISCUSSION:

The approximate length of water main to be replaced from Old Highway 63 to Eastwood Circle is 3,400 feet. This is part of a phased approach to upgrade aging water distribution infrastructure along Business Loop 70. The designed water main intersects eight (8) separate tracts of land requiring acquisition of eight (8) separate utility easements.

The Business Loop 70 Water Main Replacement has been planned through seven phases. Two Phases have been completed, and two more phases are in design stage.

FISCAL IMPACT:

This project is estimated to cost no more than \$500,000. A total of \$935,000 has been appropriated in CIP project WT0197. This project is to be funded through 2008 voter approved revenue bonds.
