

Re: Transfer of Funds to Improve and Rehabilitate Sanitary Sewer Pipes and Manholes

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration a resolution authorizing a transfer of funds from the Sanitary Sewer Utility retained earnings account to the Sewer Main Rehab capital improvement project account, to perform sanitary sewer work on the existing system.

DISCUSSION:

In fiscal year 2013, \$750,000 was included in the Sewer Utility line maintenance budget for work to reduce Inflow and Infiltration (I&I). This was anticipated to be used for either engineering studies or rehabilitation work on the sewer collection system, or a combination of the two. City staff has video inspected portions of the trunk sewers along Bear Creek and Flat Branch Creek. The inspections showed that these portions of sewer main and manholes are allowing excessive amounts of I&I into the sanitary collection system. It is recommended that the Sanitary Sewer Utility line maintenance budgeted funds be used to rehabilitate these portions of the collection system. The rehabilitation will consist of the installation of liners in the sewer mains and repairs to manholes. This rehabilitation should extend the anticipated design life of these sewers by approximately 50 years. This transfer is required for accounting purposes.

FISCAL IMPACT:

Funds in the amount of \$750,000 will be transferred from the Sanitary Sewer Utility retained earnings account to the Sewer Main Rehab capital improvement project account.
