Re: Acceptance of Privately Constructed Streets during Fiscal Year 2013

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration legislation accepting public streets, or segments of streets, which were constructed by private contract in subdivisions throughout Columbia and administratively accepted during FY 2013.

DISCUSSION:

Twenty-seven (27) streets, or segments of streets, totaling approximately 21,937 feet were constructed in subdivisions throughout Columbia in accordance with the plans and specifications prepared by the developer's engineers. These streets (list attached) were inspected by City staff to assure specification compliance, and have been administratively accepted by the Public Works department.

FISCAL IMPACT:

Snow removal is the only cost that would impact the estimated two year operating/on-going cost and that is difficult to estimate.
