Re: Appropriation for the Otho Smith Memorial at Columbia Cosmopolitan Recreation Area

EXECUTIVE SUMMARY:

The Parks & Recreation Department is requesting Council to approve an ordinance to appropriate \$10,000 in donations raised by Diamond Council for the Otho Smith Memorial project at the Antimi Sports Complex.

DISCUSSION:

The details of the Otho Smith Memorial project are reported to Council under a separate Council Memo as an Administrative Public Improvement project. Diamond Council raised \$10,000 in donations from a group of friends, family and fellow coaches of Otho Smith. The Parks and Recreation Department is requesting the appropriation of those funds to the Antimi Improvement Project, so that the Department can proceed with the improvements.

This project is eligible for the administrative public improvement process and will be presented to council in a separate report.

FISCAL IMPACT:

The total project budget is \$10,000 and is funded by a private donation from friends and family of Otho Smith. Park staff anticipates minimal additional maintenance costs with the improvements, as park staff already maintains the Antimi Sports Complex.
