Council Bill No. B 22-14

AN ORDINANCE

determining it is in the public interest to construct the Maplewood Drive PCCE #12 Sanitary Sewer Improvement Project; approving and adopting plans and specifications; determining that the work shall be done by contract; calling for bids through the Purchasing Division; providing for payment for the improvement; authorizing the City Manager to obtain, execute and record all documents necessary for the improvement; providing for compliance with the prevailing wage law and state-mandated construction safety training; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council adopted a resolution declaring the necessity of constructing the Maplewood Drive PCCE #12 Sanitary Sewer Improvement Project; and

WHEREAS, the notice of a public hearing on this project was published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held a public hearing on construction of the improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds that the construction of sanitary sewers, wye branches, manholes and other necessary appurtenances, all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, as part of the Maplewood Drive PCCE #12 Sanitary Sewer Improvement Project, is necessary for the welfare and improvement of the city and that it is in the public interest that such improvements be made.

SECTION 2. The plans and specifications for this improvement, as prepared by the Director of Public Works, are hereby approved and made a part of this ordinance by reference.

SECTION 3. The construction of the improvement shall be done by contract in accordance with the plans and specifications, the laws of the State of Missouri, and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 4. The Purchasing Agent is hereby authorized to call for bids and execute a contract for the improvement.

SECTION 5. Payment for this improvement shall be made from Sewer System Revenue Bonds, Sanitary Sewer Utility Funds and such other funds as may be lawfully appropriated.

SECTION 6. The City Manager is authorized to obtain, execute and have recorded all licenses, easements, deeds and any other conveyances or instruments necessary for the City to complete this improvement.

SECTION 7. The contract for the improvement shall provide that not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under the contract. The contractor's bond shall guarantee the faithful performance of the prevailing hourly wage clause in the contract.

SECTION 8. The bid specifications and contract for the improvement shall provide that the contractor and any subcontractor shall provide a ten-hour Occupational Safety and Health Administration construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations) for all employees working on-site. All employees working on the site of the improvement are required to complete the safety program within 60 days of beginning work on the improvement project.

SECTION 9. This ordinance shall be in full force and effect from and after its passage.

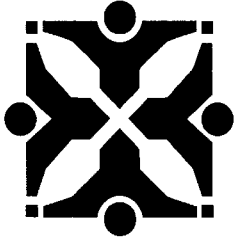

Re: Bid Call - Private Common Collector Elimination (PCCE) #12 - Maplewood Drive

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration legislation authorizing a bid call through the Purchasing department to construct the PCCE #12 - Maplewood Drive sanitary sewer project. Staff held the Interested Parties (IP) meeting for the project on September 24, 2012, and a public hearing was held on March 18, 2013. The estimated cost for this project is \$150,000, with payment from the Annual Private Common Collector elimination funds provided in the Sanitary Sewer Utility CIP.

DISCUSSION:

The proposed sanitary sewer improvement project consists of four parcels along Maplewood Drive and Manor Drive, and staff worked with the property owners on the location of the main serving their properties. The final design proposes the construction of approximately 305 linear feet of sanitary sewer main which will connect to the City's existing sanitary sewer main located on Maplewood Drive (see attached Exhibit A). Construction plans are 95-percent complete and construction is expected to begin in the summer of 2014.

FISCAL IMPACT:

The resolution estimate for this project is \$150,000, and in accordance with Section 22-253 of the City Code, funding for this project shall come from the Sewer Utility-Private Common Collector Elimination funds provided in the April 2008 and 2013 ballots. It is anticipated that this project will add minimal costs to the sewer utility's annual operating costs.
