# **AN ORDINANCE**

determining it is in the public interest to construct roadway pavement improvements on Clark Lane, between Woodland Springs Court and McKee Street; approving and adopting plans and specifications; determining that the work shall be done by contract; calling for bids through the Purchasing Division; providing for payment for the improvement; authorizing the City Manager to obtain, execute and record all documents necessary for the improvement; providing for compliance with the prevailing wage law and state-mandated construction safety training; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council adopted a resolution declaring the necessity of constructing roadway pavement improvements on Clark Lane, between Woodland Springs Court and McKee Street; and

WHEREAS, the notice of a public hearing on this project was published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held a public hearing on construction of the improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds that the construction of roadway pavement improvements and other miscellaneous work, all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, on Clark Lane between Woodland Springs Court and McKee Street, in the City of Columbia, Missouri, is necessary for the welfare and improvement of the city and that it is in the public interest that such improvements be made. Specific roadway improvements are as follows:

- Widening the pavement by five-feet on both sides of Clark Lane.
- Narrowing the driving lanes from 12-feet to 11-feet.

- Re-striping the driving lanes to provide six-foot wide shoulders on both sides of Clark Lane,
- Replacing approximately 4,300 feet of stormwater pipe east of Robert Ray Drive.

SECTION 2. The plans and specifications for this improvement, as prepared by the Director of Public Works, are hereby approved and made a part of this ordinance by reference.

SECTION 3. The construction of the improvement shall be done by contract in accordance with the plans and specifications, the laws of the State of Missouri, and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 4. The Purchasing Agent is hereby authorized to call for bids and execute a contract for the improvement.

SECTION 5. Payment for this improvement shall be made from Capital Improvement Sales Tax Funds and such other funds as may be lawfully appropriated.

SECTION 6. The City Manager is authorized to obtain, execute and have recorded all licenses, easements, deeds and any other conveyances or instruments necessary for the City to complete this improvement.

SECTION 7. The contract for the improvement shall provide that not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under the contract. The contractor's bond shall guarantee the faithful performance of the prevailing hourly wage clause in the contract.

SECTION 8. The bid specifications and contract for the improvement shall provide that the contractor and any subcontractor shall provide a ten-hour Occupational Safety and Health Administration construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations) for all employees working on-site. All employees working on the site of the improvement are required to complete the safety program within 60 days of beginning work on the improvement project.

SECTION 9. This ordinance shall be in full force and effect from and after its passage.



**Re:** Clark Lane Improvements - Woodland Springs Court to McKee Street Bid Call

## EXECUTIVE SUMMARY:

Staff has prepared for Council consideration legislation authorizing a bid call through the Purchasing division for the construction of the widening of both sides of Clark Lane to provide shoulders from Woodland Springs Court to McKee Street (see attached location map). A public hearing was held on January 21, 2014.

## DISCUSSION:

At the January 21, 2014 public hearing, Council directed staff to proceed with plans and specifications for the Clark Lane Non-Motorized Improvements project. Staff will evaluate modifications discussed during the public hearing such as crosswalks, lighting, speed limits, and rumble strips as final plans are prepared. The final design includes construction of full depth asphalt shoulders, to be used as future driving lanes with a forthcoming project to improve Clark Lane to a complete street, with dedicated bicycle lanes and sidewalks, as shown in the attached cross section. The project length is approximately 4,300 linear feet. A location diagram and plan sheets are attached.

A stormwater pipe just east of Robert Ray Drive, that carries water under Clark Lane, is extensively corroded and will need to be replaced. This will result in the closure of Clark Lane for at least three days.

## FISCAL IMPACT:

Funds in the amount of \$600,000 have been appropriated to this project from Capital Improvement Sales Tax.






