

Commission Report

City of Columbia Vision Commission Media Mention Report - April 2014



The Columbia Vision Commission tracks media coverage of Vision Topics every month to determine visibility and interest in the wider community through the major media sources (Columbia Tribune, KOMU, Columbia Missourian, etc.). The Commission categorizes each article or mention into the Vision topics that it best fits into, which could be one or multiple topics.

The vision topics that received the most mentions in the media for April, as observed by the Commission, were Education with 42 mentions, Community Facilities & Services with 31 mentions, and Economic Development and Downtown tied with 30 mentions. The major media events that occurred in relation to education were the Columbia Public School's (CPS) Board of Education election, the passage of the Bond issue for school construction, and improving the salary schedule for CPS faculty and staff. Community Facilities & Services media mentions included the purchase of land for a homeless day center, Columbia Water and Light attempts to build a solar array, and the completion of plans for the new 911 Center. Economic Development mentions were the petition to repeal the Opus Development and the Columbia City Council rescinding the Opus agreement and the work on creating a new agreement. Downtown media mentions included vandalism of businesses and new food truck rules adopted by City Council.

Major media mentions that were discussed in other topics were the discussion of changes to the C-2 zoning code, the construction of the natural gas station, Columbia City Council elections, and continuing efforts to fund downtown infrastructure improvements.
