Executive Summary

This Code amendment removes the historical reference to service of special meeting notices upon council members by a police officer.

Discussion

Section 2-22 of the City Code has been in effect since prior to 1952 and provided a means by which notice of special meetings was provided to the city council. The original intent of such notice provision was to ensure meetings of a majority of the governing body were not held to the exclusion of some members. Individual council members waive the service notice by a police officer by consenting to other forms of notice and currently use email to provide such notice. With the advent of the Sunshine Law and modern methods of communication, the City Code needs to be amended to remove the reference to service by a police officer.

Since the practice of the City has been to provide notice of meetings to the City Council via email, it is recommended the City Code be amended to reflect current practice. The amendment specifically authorizes email delivery and requires notice be further provided as set forth in Sec. 2-25 (which is the Sunshine Law public notice and posting requirement).
