Executive Summary

Appropriating funds from the General Fund balance to Street division operating accounts to cover expenses incurred as a result of snow events this past winter.

Discussion

Due to the considerable expenses incurred by Street division during the large snow events this past winter, Street maintenance and snow removal accounts are over budget, particularly in fleet maintenance and equipment. Staff is is requesting an appropriation in the amount of \$133,000 from the General Fund balance to Street division operating accounts in order to sustain the budget for the remainder of this fiscal year.
