#### **Executive Summary**

At the request of council member Chadwick, a right of use permit with The Curators of the University of Missouri has been prepared. The right of use permit allows enforcement of the University's smoking policy on certain city street rights-of-way during times when such rights-of-way are lawfully closed to restricted vehicular traffic.

#### **Discussion**

The right-of-use permit allows enforcement of the University's smoking policy, as amended from time to time, on certain city streets that are lawfully closed to restrict vehicular traffic in the permit. The streets lawfully restricted are: Conley Avenue, Hitt Street, Ninth Street and Rollins Street. These streets are within the current closed campus areas and the exact areas are described in the right of use permit. The permit is a license that shall remain in effect until canceled by the city manager. Generally, notice of cancellation will be given six (6) months in advance.

This permit is subject to the following conditions and stipulations:

1. This permit and license shall remain in effect until canceled by the City Manager. Written notice of cancellation shall be given to the Permittee six (6) months in advance, but may be given with no advance notice if deemed necessary or desirable by the City Manager to serve the best interest of the public.
