Executive Summary

Setting a public hearing for October 20, 2014 concerning the construction of sanitary sewers to serve 13 properties located within the PCCE #20 Ridgemont Sanitary Sewer Improvement District. These parcels are located on Ridgemont Road, between Highridge Circle and Highridge Drive, and are currently served by a private common collector sewer. The resolution estimate for this project is \$250,000, which includes construction and design costs.

Discussion

The proposed sanitary sewer improvement project consists of 13 parcels along Ridgemont Road which are currently connected to a private common collector sewer. Some of the properties have been experiencing problems with sewer service due to a combination of poor construction, degradation and lack of routine maintenance and repair of the private sewers. The existing private common collector sewer does not meet City standards, is in poor structural condition, and is in need of replacement.

On August 16, 2009, seven (7) property owners submitted a petition for the formation of a Sewer Improvement District in order to replace the private common collector sewers. At the October 19, 2009 Council meeting, Council directed staff to proceed with the preliminary design in order to determine the feasibility and cost of a sewer district for this area. Staff held an Interested Parties (IP) meeting on July 23, 2014. Seven (7) property owners attended, and indicated their support for the sanitary sewer improvements. The remaining properties owners not in attendance, were contacted by staff to discuss the proposed improvements.

The proposed sanitary sewer improvements will consist of the construction of approximately 940 linear feet of 8-inch PVC main, nine (9) manholes and the installation of service connections and sewer service laterals necessary to connect the existing structures to the new public sewer main. The total resolution estimate for this project is \$250,000, and payment shall come from the Annual Private Common Collector Elimination funds provided by the Sanitary Sewer CIP.

Fiscal Impact

Short-Term Impact: In accordance with Section 22-253 of City Code, funding for the sanitary sewer project shall come from the Sewer Utility - Private Common Collector Elimination funds provided in the November 2013 ballot, Sanitary Sewer Utility CIP.

Long-Term Impact: Sewer maintenance cost for upkeep of the sewer is anticipated to be approximately \$100 per year.


