### **Executive Summary**

Setting a Public Hearing for October 20, 2014 concerning the construction of a single ADA compliant family restroom to be located in the passenger holding area, and a snack bar in the terminal lobby area, at the Columbia Regional Airport. The estimated construction cost is \$76,137.

#### Discussion

Once passengers pass through the TSA security checkpoint at the Columbia Regional Airport, they move to the passenger holding area, which consists of two modular buildings accommodating approximately 130 people. Currently, if a passenger waiting in the holding area wishes to use the restroom facilities, they must exit back through the TSA screening area, and then would have to be re-screened in order to re-enter the holding area. Today, the Columbia Regional Airport is on track for the highest passenger enplanement since 1986. A public restroom inside the secure passenger holding area will allow for more efficient screening and less disruption to the screening process.

The restaurant, currently located on the second floor of the Columbia Regional Airport, is inaccessible to many disabled and elderly visitors, and does not meet current ADA requirements. The proposed first floor terminal snack bar will accommodate all visitors.

A professional architectural services agreement with Simon Oswald Associates, Inc was authorized in June of 2014 to design a single ADA compliant family restroom to be located between the terminal and the existing modular buildings, and a snack bar to be located adjacent to the TSA security zone in the main terminal lobby, at the Columbia Regional Airport. The architect's diagrams and opinion of probable costs are attached.

### Fiscal Impact

Short-Term Impact: The cost for architectural services to design the two projects was \$14,960, and the construction costs are estimated at \$76,137, to be paid from Transportation Sales Tax funds.




