Executive Summary

The Share the Light program began in August 2001 as a way for residents to contribute to a range of City of Columbia projects through their utility bill on a one-time or monthly basis. As of November 1, 2014, more than \$215,100.00 has been raised for six areas of city programming. The six areas are community arts programming, community beautification, youth recreation scholarships, public health, fire prevention and education, and crime prevention. Each donation is made for a specific area of programming and is to be used only for programming in that area of giving. Staff is requesting appropriation of Share the Light funds already donated for use by the Columbia Fire Department and Community Development.

Discussion

The Share the Light program allows Columbia residents to contribute to one or more of six areas of city programming that extend beyond basic City services. The six areas are community arts programming, community beautification, youth recreation scholarships, public health, fire prevention and education, and crime prevention. Since Share the Light started, more than \$180,100.00 has been appropriated (including this request) throughout all six program areas.

This appropriation request totaling \$6,238.27 is for two departments:

- 1. Columbia Fire Department requests \$738.27 to purchase 13 carbon dioxide detectors @ \$26.97 each, and 91 smoke alarms @ \$4.26 each. The detectors/alarms will be distributed to low-income Columbia residents by the Fire Department.
- 2. Community Development-Volunteer Programs requests \$5,500.00 to support the Adopt-A-Spot Beautification Program. The City has more than 95 landscaped beds in City or State Right of Way cared for by volunteers. These beds are seen by thousands of residents and visitors every day and reflect our community pride. Volunteer Programs is requesting funds to hire an intern with landscaping and horticulture knowledge and/or experience to work with volunteers on the beds that need the most attention due to lack of maintenance in order to improve the quality of the program. Should the funds be appropriated, an intern will be hired to assist with this program from Spring through Fall, focusing on beds with the greatest need of attention.
