Executive Summary

Setting a public hearing for January 5, 2015 to consider the installation of speed humps on Derby Ridge Drive, between Smiley Lane and Brown School Road, and between Blue Ridge Road and Smiley Lane. The estimated cost of this project is \$32,000.

Discussion

Derby Ridge Drive scored as the highest priority project within the Neighborhood Traffic Management Program (NTMP), with a score of 88 out of a possible 100. The scoring system takes a number of factors into consideration including: speed, volume, pedestrian generators in the area, proximity to schools, bike routes and recent accident history. The majority of the scoring ($\frac{2}{3}$) is based on speed and volume of vehicles. The speed limit on Derby Ridge is set at 25 mph; however, this street scored at the 85th percentile speed of 39.65 mph, and has over 2,400 vehicles traveling on it per day.

Interested Parties (IP) meetings were held at the Derby Ridge elementary school on August 5th and again on September 29th. During the first meeting, staff gathered information from the public and listened to potential solutions. The overwhelming majority of those in attendance recommended, and were in favor of, placing speed humps on Derby Ridge Drive to encourage lower speeds. Using the information gathered at the August 5th IP meeting, and taking into account that Derby Ridge is over 1.25 miles in length, two plans were developed and presented at the September 29th IP meeting.

Plan 1 (North Option) included construction of four speed humps on Derby Ridge Drive between Smiley Lane and Brown School Road.

Plan 2 (South Option) included construction of four speed humps on Derby Ridge Drive between Blue Ridge Road and Smiley Lane. With this plan there were two options identified. Option A with four speed humps placed closer to Smiley Lane, and Option B with four speed humps placed closer to Blue Ridge Road.

Individuals attending the September 29th IP meeting favored both Plan 1, and Plan 2 with Option B. Staff proposes to construct a total of eight speed humps on Derby Ridge Drive with four speed humps

located between Smiley Lane and Brown School Road, and four additional speed humps located between Blue Ridge Road and Smiley Lane. Diagrams showing the locations of the speed humps are attached. Construction of the speed humps is expected sometime in 2015.

Fiscal Impact

Short-Term Impact: The estimated cost for installation of eight speed humps is \$32,000, and will be paid from Street division's traffic safety account.

Long-Term Impact: Staff anticipates the replacement of the speed humps every 15 years.

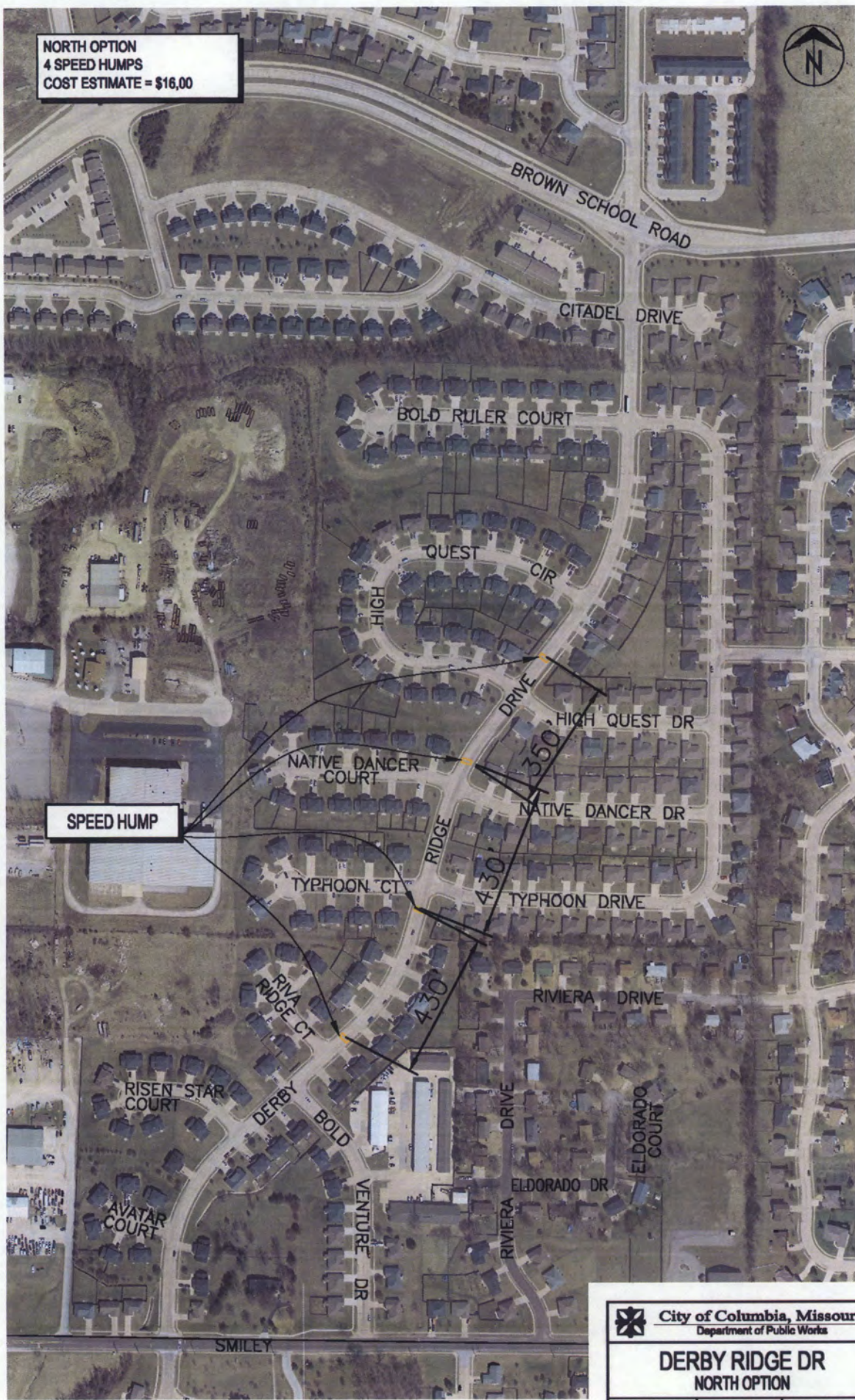

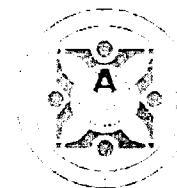

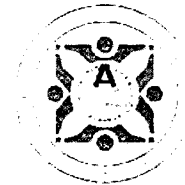

A RESOLUTION

declaring the necessity for construction of traffic calming speed humps along Derby Ridge Drive, between Smiley Lane and Brown School Road and between Blue Ridge Road and Smiley Lane; stating the nature of and the estimate of the cost of the improvement; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of four traffic calming speed humps along Derby Ridge Drive between Smiley Lane and Brown School Road, and four traffic calming speed humps along Derby Ridge Drive between Blue Ridge Road and Smiley Lane, all in accordance with City of Columbia Specifications and Standards, necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 3. The estimated cost of this improvement is \$32,000.00.

SECTION 4. Payment for this improvement shall be made from transportation sales tax funds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on January 5, 2015. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.
