### **Executive Summary**

Staff has prepared a report for Council with an update of recycling drop-off site locations within the City of Columbia. There are currently just nine drop-off locations, and to date no other alternative sites have been located.

#### Discussion

Due to the elimination of two recycling drop-off sites; one at the Gerbes on Paris Road and more recently another at the Gerbes on West Broadway, staff is striving to identify additional sites. The elimination of the Paris Road site coincides with a decrease of over 886 tons (31%) in diverted tonnage from drop-off recycling from FY13 to FY14.

Because sites on private property are vulnerable to changes in property use, preference is to place sites on city-owned property for better long term security; however, partnering with corporate or private individuals is always an option. The key to site success is to be located in a high traffic area, for easy access and to prohibit illegal dumping. Approximately 10,000 square feet is sufficient for placing and accessing collection containers.

As shown on the attached diagram, the Solid Waste division currently has nine drop-off sites, with just two sites located on city-owned property. One of those sites is located at the Columbia Regional Airport for fiber collection only. There are no recycling drop-off sites currently in the region lying both west of Providence and south of Business Loop, which covers a large portion of the city limits and population. Staff would like to construct a drop-off site on the city-owned property formerly utilized for Fire Station #7 on S. Providence, which will alleviate overflow from the State Farm Parkway site as well as reach additional citizens. Additional locations are needed farther west as well as in northern corridors of Paris Road/Route B and N. 763. Staff is seeking suggestions from Council and/or other City departments to locate possible sites on city-owned property with high visibility and high traffic areas.
