# **Executive Summary**

In light of proposed changes to Chapter 28 which would establish new requirements for Transportation Network Companies (TNCs) like Uber, Sidecar and Lyft who operate in the same business arena as traditional taxicabs, and with the intent to keep both traditional taxicabs and TNCs on a competitive, level playing field, staff conducted a survey of taxicab companies to help determine any needed changes to the existing taxicab regulations. A copy of the survey is included.

## Discussion

The proposed ordinance changes reflect a consensus of the responses to the survey which are summarized briefly below:

- An office would only be required for taxicab or limousine companies operating more than one vehicle.
- Remove requirement for a landline phone.
- Added an option for a phone in the taxicab in lieu of radio for communications between dispatcher and the driver.
- Taxi stand hours to be changed from "9:00 p.m. 2:30 a.m." to "11:00 p.m. to 2:00 a.m.".

With the exception for small fee increases and minor administrative changes, there have been few changes to Chapter 28. The requirement for taxicab stands as they currently exist in the downtown area was added in February, 2012 (Ordinance No. 21231, Council Bill B25-12A).

## **AN ORDINANCE**

amending Chapter 14 and Chapter 28 of the City Code as it relates to taxicab businesses and taxi stand hours; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 14 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 14-295. Taxi stands designated.

When signs are placed, erected or installed giving notice thereof, the following zones shall be designated as stands for designated vehicles only and no person shall park a vehicle other than a taxi, limousine, bus or STRIPES vehicle between  $\frac{9:00-11:00}{2:30-2:00}$  p.m. and  $\frac{2:30-2:00}{2:00}$  a.m.:

Sec. 14-296. Duties of bus and taxicab operators.

(a) The operator of a bus shall not stand or park such vehicle upon any street at any place other than a bus stand so designated as provided herein.

. . .

(e) <u>A transportation network operator shall not stand or park such vehicle in a</u> <u>designated taxicab stand at any time.</u>

SECTION 2. Chapter 28 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 28-86. Responsibility of permit holder.

(a) Each permit holder operating a taxicab business with more than one (1) taxicab owned or operated by permit holder or limousine service with more than one (1) limousine owned or operated by permit holder is required to maintain an office within the City of Columbia with regular business hours. A responsible representative of the permit holder shall be available during regular business hours to receive reports of lost articles, complaints, injuries and related matters. Each permit holder shall maintain a listing in all business directories commonly available to the public listing scheduled business hours. Each permit holder shall maintain a publicly listed business telephone number.

. . .

Sec. 28-96. Service.

(a) Holders of taxicab business, limousine service or other permits under this article shall offer city-wide services. Taxicab business services shall include the transportation of passengers, messages and packages.

. . .

(c) All holders of taxicab business permits shall provide telephone answering and radio dispatching capabilities during scheduled business hours and all taxicabs shall be equipped with radios <u>or phones</u> for two-way communications between driver and dispatcher.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.



### 1.b. If your answer is "no", please explain.


it make intoxicated people to gather at the same location and cause fights over cabs. it makes intoxicated people walk around aimlessly because the taxi stands are not clearly marked.

here are my comments why I don't like them.


# 2. What change would you most like to see to the current taxi stand provisions, if any?



Comments: Color No, lettering scheme Yes. yes, with reversible colors for same company.


4. Do you agree that every taxi business should maintain an office within the City in an appropriately zoned location with regular business hours and a land line phone?





Location of Locust and 10th stand. Move it to the north side of street. 10th and Broadway make the whole street between Locust and Broadway spaces for Taxi's Move cab stand hours to 6pm. This will cut down on people parking before the 9pm deadline and not comming out to move these vehicles. Allow Taxi Companies the ability to have the cars towed after a ticket has been issued for parking in a Taxi stand. Too many times the cops come and ticket and the cars remain, allow the tow companies the ability to take any ticketed vehicles without being called by the police. Cab Stand signage needs to be more visible, placed at eye level.
