Executive Summary

Authorizing the City Manager to execute a supplemental agreement to the STP-Urban Program agreement with the Missouri Highways and Transportation Commission (MHTC) for the Broadway pavement improvement project from Providence Road to Hitt Street. This supplemental agreement extends the deadline for plans, specifications and estimates (PS&E), advertisement for letting and the bid opening by four (4) months.

Discussion

On December 2, 2013, Council passed Ordinance 21912 authorizing an STP-Urban Program agreement with MHTC for the Broadway pavement improvement project from Providence Road to Hitt Street. The current project schedule obligates that final plans and specifications must be submitted to MoDOT by May 1, 2015, and approved by June 1, 2015. This supplemental agreement would extend those deadlines by four (4) months.

MoDOT observed an approximate six (6) month lag in securing professional engineering services for this project, and recommended a four (4) month extension for PS&E. Although the project is currently on schedule, staff admits that the existing schedule is aggressive, and agrees that extending the deadline by four (4) months would ensure that any unforeseen delays would not jeopardize the 80% funding from MHTC.

SUPPLEMENTAL AGREEMENT**

THIS SUPPLEMENTAL AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and the City of Columbia (hereinafter, "City").

WITNESSETH:

WHEREAS, on December 23, 2013, the Commission and the City previously entered into a STP-Urban Funds Agreement as to public improvements designated as transportation improvements, for the construction of pavement improvements with milling and thin lift overlay on Broadway between Providence Road and Hitt Street. This project will also include ADA improvements by replacing approximately 35 curb ramps (hereinafter, "Original Agreement"); and

WHEREAS, the Commission and the City now desire to revise the Original Agreement as provided in this Supplemental Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations contained herein, the parties agree as follows:

(1) REVISION: Exhibit B of the Original Agreement is hereby removed and replaced with the following:

(2) ORIGINAL AGREEMENT: Except as otherwise modified, amended, or supplemented by this Supplemental Agreement, the Original Agreement between the parties shall remain in full force and effect and shall extend and apply to this Supplemental Agreement as if fully written in this Supplemental Agreement.
