Executive Summary

Volunteer Programs, part of the Community Development Department, is submitting for approval three Adopt-A-Spot Beautification agreements to allow volunteers to care for landscaping in street right of way.

Discussion

Volunteers maintain more than 90 landscaped beds in city or state right of way in the City of Columbia. Adopters are responsible for weeding, watering, and mulching the beds and planting annual flowers and bulbs. Agreements are written for a four-year commitment and each bed has a sign to acknowledge the efforts of the adopter.

Staff is submitting three agreements for approval. All three beds are existing and have landscape material in them:

- Amy Sallady and Columbia Family Law Group will adopt an existing bed located at the northwest corner of West Broadway and Fairview Road.
- -The MU Staff Advisory Council led by Julie Loftin have agreed to adopt the median bed located in Green Meadows Road east of Providence Road.
- -Hayes Murray has agreed to adopt an area of landscaping just north of Stadium Boulevard north of the Forum intersection. This area surrounds a sidewalk connecting to Westwinds Drive.

City staff will work with these volunteers to provide mulch, annual flowers, bulbs and replacement plants as needed to help them be successful. The City's Volunteer Programs staff appreciates the investment that volunteers put into Adopt-A-Spot beds to be enjoyed by hundreds of residents and visitors each day.

Fiscal Impact

Short-Term Impact: The City will provide signs acknowledging the work of each adopter for a total cost of \$390. In addition the City will provide mulch, plants, annuals and bulbs for a total two year cost not to exceed \$750.

Long-Term Impact: The City's Volunteer Programs provides ongoing support for Adopt A Spot beds including water meter and hydrant maintenance and repair, replacement plants, mulch, bulbs and annual flowers. No more than \$15,000 is spent on the program to support more than 95 beds. Volunteers provide the labor to maintain these beds at no cost to the City.
