### **Executive Summary**

Transfer funds to reimburse/pay some costs associated with the formation of the Business Loop Community Improvement District (CID).

#### **Discussion**

The Business Loop CID provided a check for \$1,250.00 to reimburse the city the notification costs in terms of advertising the public hearing and notifying property owners of the public hearing as required by state statutes. Those funds were placed in a revenue account, and a transfer is now needed to an expense account so those costs can be reimbursed/paid.

Authorization of the transfer would allow reimbursement/payment of those costs.

The Council also agreed to upfront the costs associated with the review and analysis of the Business Loop CID petition at the January 5, 2015 Council Meeting. The Business Loop CID will be asked to reimburse those costs as well, and another transfer or an appropriation will be needed when those costs are reimbursed.
