

## Executive Summary

An ordinance amending the FY 2015 Annual Budget and Permanent Full-Time Position Count to eliminate vacant 1.0 FTE WIC Office Specialist, add .50 FTE Nutritionist, and increase .50 FTE to 1.0 FTE Administrative Support Assistant for the Department of Public Health and Human Services.

## Discussion

The Public Health & Human Services Department is requesting a budget amendment to better address the current needs in the WIC and Community Nutrition division. More nutrition expertise is needed for nutrition education and nutritional assessment of WIC clients. Without the WIC Office Specialist, more clerical time will be needed at the WIC front desk. By eliminating a vacant position and redirecting the funds to increase clerical and nutrition functions, funding will be used more appropriately for current needs. No classification or pay plan amendments are required since these classifications already exist. This amendment is cost neutral.

## Fiscal Impact

Short-Term Impact: None. Funds related to eliminated position combined with \$2,500 surplus department overtime funds (from Community Health Nursing Administration - 3310) will offset the increase in personnel funding.

Long-Term Impact: None.



**AN ORDINANCE**

amending the FY 2015 Annual Budget by deleting and adding positions in the Department of Public Health & Human Services – Women, Infants and Children Division; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2015 Annual Budget adopted by Ordinance No. 022207 is amended by deleting the following position in the Department of Public Health & Human Services – Women, Infants and Children Division authorized personnel:

1.00 FTE 7451 WIC Office Specialist Grade B5 OT Non-Exempt

SECTION 2. The FY 2015 Annual Budget is further amended by adding the following positions to the Department of Public Health & Human Services – Women, Infants and Children Division authorized personnel:

0.50 FTE 7403 Nutritionist Grade C5 OT Exempt  
0.50 FTE 1005 Administrative Support Assistant Grade B5 OT Non-Exempt

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
