Executive Summary

Authorizing an amendment to Chapter 14 of the City Code to prohibit parking along a portion of Greeley Drive at all times.

Discussion

In November of 2014, staff received a request to address parking issues along Greeley Drive. This street is approximately 20 to 22 feet wide, with no current parking restrictions. Staff contacted the Fire Department regarding access, and a field inspection concluded that if vehicles were parked on both sides of the street, it would be difficult to navigate through in a safe manner (see attached e-mail).

In January of 2015, staff sent a letter to property owners along Greeley Drive (attached) seeking feedback concerning a possible parking prohibition on the street. Following is a summary of the responses received from the property owners.

- 2 do not restrict parking;
- 2 restrict parking on both sides;
- 1 restrict parking on one side:
- 1 letter response is from the same name & address as a survey response;
- 1 letter response is from an unknown name & address.

Based on comments received from the Fire Department, staff recommends that parking be restricted on one side of the street, and proposes the restriction on the north side based on the convenience for vehicles coming from Brown Station Road to park on the south side of the street when entering Greeley Drive.

Fiscal Impact



Yes, I believe there are access problems. There is enough room for us to drive past the vehicles. The problems will occur if there are other vehicles parked on the opposite side of the street. The street will be completely blocked. Also, if there are vehicles parked on the opposite side, down from those that are shown in the photos, there is not enough room for the apparatus to "weave" past the parked vehicles. Then, we will not be able to get through. As far as outriggers, there is no room to deploy them if there are vehicles parked on the street. We will have to stop short, or drive past the parked vehicles to deploy the outriggers.
