Executive Summary

Authorizing an amendment to Chapter 14 of the City Code to relocate a designated taxi stand on Tenth Street, just south of Broadway to its original location on Tenth Street, just north of Broadway.

Discussion

On July 7, 2014 Council passed Ordinance 22111 to relocate a designated taxi stand which was located on Tenth Street, just north of Broadway to a new location on Tenth Street, just south of Broadway, to allow for the construction of an apartment building located on the northeast corner of Tenth and Broadway. The construction of the apartment building is now complete and staff is recommending that the taxi stand be relocated to its original location on Tenth Street just north of Broadway. Staff has contacted both the Columbia Police Department and the CID and they are in support of relocating the taxi stand to its original location.

AN ORDINANCE

amending Chapter 14 of the City Code to relocate a taxi stand on Tenth Street; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 14 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Material to be deleted in strikeout; material to be added underlined.

Sec. 14-295. Taxi stands designated.

When signs are placed, erected or installed giving notice thereof, the following zones shall be designated as stands for designated vehicles only and no person shall park a vehicle other than a taxi, limousine, bus or STRIPES vehicle between 11:00 p.m. and 2:00 a.m.:

Broadway, north side, between Waugh Street and a point two hundred eighty (280) feet east of Waugh Street.

. . .

Tenth Street, west side, between Broadway and the alleyway just north of Broadway six (6) parking spaces on the east side beginning at the Broadway intersection and going south toward Cherry Street.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.


