Executive Summary

An ordinance authorizing the City Manager to sign the Healthy Eating and Active Living (HEAL) Memorandum of Understanding (MOU) between the City of Columbia and Columbia Public Schools.

Discussion

Columbia Public Schools (CPS) and the Columbia/Boone County Department of Public Health and Human Services (PHHS) are partnering through this MOU to increase physical activity through employee wellness programs at CPS. The funding used to support this programming is from the Healthy Eating and Active Living Grant. This is the second year PHHS has received this grant. Last year, PHHS partnered with CPS and successfully created lactation rooms in all CPS buildings using HEAL grant funding. This year, the PHHS and CPS partnership will focus on promoting physical activity via a Million Step Challenge.

Memorandum of Understanding

between Columbia Public Schools (CPS)
and the City of Columbia, Missouri, on behalf of its Columbia/Boone County
Department of Public Health & Human Services (PHHS)
Healthy Eating and Active Living (HEAL)
October 1, 2015 – September 30, 2016

This MOU outlines the roles and responsibilities between Columbia Public Schools and PHHS in implementing an employee wellness intervention, million steps, or other worksite wellness programs and/or events that promote health and wellness among CPS employees.

By signing this MOU, both partners commit to working together through September 30, 2016. Both partners agree to the following roles and responsibilities:

CPS will:

- Assess the worksite health needs of CPS employees
- Plan and develop a worksite wellness program, including a million steps program
- Implement the million steps programs and host at least two additional events or programs to promote worksite health
- Reimburse employees for reaching a million steps
- Collaborate with PHHS to promote worksite health and coordinate health promoting events
- Provide monthly program updates to PHHS
- Provide monthly invoices and billings to PHHS. The final invoice is due September 30, 2016. The total cost of the project shall not exceed \$25,000.

PHHS will:

- Serve as contract facilitator and ensure contract deliverables are met
- Act as a resource to provide technical assistance with the million steps program and other worksite wellness events
- Collaborate with CPS to promote worksite health and coordinate health promoting events
- Provide payment for all invoices.
