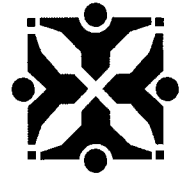

## Executive Summary

A resolution has been prepared that would reappoint Robert Aulgur to the position of municipal judge.

## Discussion

Under the City Charter, the Council appoints a municipal judge for a term of four years. Robert Aulgur was initially appointed municipal judge on October 20, 2003 for a four year term beginning October 27, 2003. Mr. Aulgur was re-appointed municipal judge on September 2, 2007 for an additional four year term beginning October 27, 2007, and reappointed again on August 1, 2011 to a four year term beginning October 27, 2011.

Council moved the performance review process for Council employees to October this year. The appointment date for the municipal judge will move to February to accommodate that process. The municipal judge serves under his/her current appointment until he/she is reappointed or replaced. A resolution has been prepared that would reappoint Mr. Aulgur to a new four year term beginning February 1, 2016.

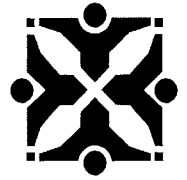
