Executive Summary

The Broadway Sidewalk reconstruction project, from Eighth Street to Ninth Street, was completed in 2011, and public hearings were held December 5, 2011 and January 3, 2012 concerning special assessments against properties benefited by and abutting the constructed sidewalk improvements. Since this project was located within the downtown central business district, it was eligible for a 50/50 cost share with the City, per the Sidewalk Maintenance and Construction policy.

At the January 3, 2012 Council meeting, Council Bill 329-11 accepting and approving the work of the Broadway Sidewalk project, and levying special assessments and authorizing the issuance of special tax bills against the parcels benefited and abutting the improvements was amended to remove one parcel from the legislation due to issues to be worked out between the property owner, Arnold Fagan, and the City. It was determined that staff would come back to Council to impose the tax bill on Mr. Fagan's property once the issues were mutually resolved.

Discussion

The Broadway Sidewalk project constructed during the summer of 2011 involved the reconstruction of sidewalk and installation of a water main along the south side of Broadway from Eighth Street to Ninth Street. The existing sidewalk along this corridor did not meet the downtown sidewalk standards due to excessive cross slope and deterioration of the surface at many locations. The project also included installation of electrical conduit for street lights, tree grates and decorative brick pavers. Two vaults under the sidewalk were filled and capped as well as two skylights. A new 12" water line, connecting the existing water lines under Eighth and Ninth Streets, was constructed by the Water & Light department.

On December 5, 2011, a public hearing was held and Council Bill 329-11 was proposed to accept the work on the project and levy special assessments and authorize the issuance of special tax bills against the parcels benefited and abutting the sidewalk improvements. Due to Mr. Fagan's claim that moisture in his basement was caused by the sidewalk reconstruction project, Council tabled the

public hearing to January 3, 2012 to allow staff time to address this issue. An excerpt from the meeting minutes, proposed legislation, and supporting documentation from the December 5, 2011 Council meeting are attached.

On January 3, 2012, Council further discussed the issue concerning Mr. Fagan's claim of moisture in his basement and determined that since it was not known whether the moisture was an issue before or after the sidewalk was installed, that the legislation be amended to remove the portion of the tax bill associated with Mr. Fagan's property. The City attorney further suggested that if there was a dispute between Mr. Fagan and the City, that it would be best to resolve through a settlement agreement. If that couldn't be accomplished, a separate ordinance imposing the tax bill for Mr. Fagan's property could be brought forward in the future. A motion was made and passed removing parcel number 16-320-00-17-133.00.01 from the legislation, which had a special assessment of \$5,959.03. An excerpt from the January 3, 2012 Council meeting minutes and amended Council Bill 329-11A are attached.

To date, staff has been unsuccessful in resolving this issue with Mr. Fagan and his attorney. Staff recommends moving forward with Legal's earlier recommendation to treat the tax bill issue separately from a settlement agreement, and recommend Council pass the legislation to impose the tax bill on Mr. Fagan's property in the amount of \$5,959.03. Mr. Fagan has the option to pursue a settlement agreement with the City.

Fiscal Impact

Short-Term Impact: The eligible cost for the sidewalk reconstruction was \$45,716.50. With the 50/50 cost share program, the property owners for the abutting properties were responsible for a total of \$22,858.25 in special assessments. Mr. Fagan's portion of this assessment is \$5,959.03. Long-Term Impact: N/A

AN ORDINANCE

levying a special assessment and authorizing the issuance of a special tax bill as it relates to the reconstruction of the sidewalk along the south side of Broadway, from Eighth Street to Ninth Street, in the City of Columbia, Missouri; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council passed Ordinance No. 020639 on June 7, 2010 to authorize the construction of sidewalk improvements along the south side of Broadway, from Eighth Street to Ninth Street; and

WHEREAS, this public improvement was completed by JC Industries, Inc.; and

WHEREAS, the Council received the final report of the Director of Public Works in connection with this street construction, and public hearings were held on December 5, 2011 and January 3, 2012 regarding the levy and amount of special assessments in connection with the street construction project; and

WHEREAS, after due consideration to the comments of interested parties, the special benefits to the abutting properties, detriment, if any, to the abutting properties, the effect of the sidewalk construction on the present use of the properties and general benefits to the public in making the determinations set forth therein, the City Council passed Ordinance No. 021194 on January 3, 2012 to levy special assessments and authorize the issuance of special tax bills; and

WHEREAS, prior to passage of Ordinance No. 021194, the Council amended the ordinance to delay the issuance of a special tax bill against one parcel due to the property owner's claims of issues with construction of the project; and

WHEREAS, Public Works Department staff has been unsuccessful in resolving the issues claimed by the property owner and recommends moving forward with the levy of a special assessment and authorize the issuance of a special tax bill against the remaining parcel.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. A special assessment is hereby levied at a rate of \$122.2366 per front foot against the lot, and parcel of ground specially benefited by and fronting or abutting along the new construction in proportion to the number of fronting or abutting feet, the assessment is levied as follows:

SECTION 2. The City Clerk is hereby authorized and directed to issue special tax bill immediately against the lot, tract and parcel of ground as described above which is hereby declared to have been specially benefited in the amount assessed, which tax bill shall be signed by the City Clerk under the corporate seal of the City; and the City Clerk shall register the tax bill in the office of the Director of Finance for collection. The special tax bill shall mature and shall be due and payable sixty days (60) after the date of issue. After the expiration of sixty (60) days, the tax bill shall bear interest at the rate of 3.25 percent per annum on the unpaid balance until paid.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.

apparent that many students appreciated an expanded transit system, but the majority did not know what that meant. In addition, there were many issues with the current system that needed to be fixed in order to adequately serve everyone. The routes needed to be more frequent and less confusing and the requirement of a transfer at the Wabash Station was time consuming and did not make sense for most students. She explained she knew this because she had asked the students and felt that had been lacking. Those on the Task Force only represented a few voices. If they wanted the entire student body behind a solution to the issue, they needed to include them in the process. With the support of PedNet and the CoMET Campaign, she and others had started a Transit Visioning Committee on campus to find out what the students really needed and wanted from a transit system because while many students were unaware of the transit situation, she believed with the right information and the appropriate engagement they would be on board. Their intention in forming the committee was to create a campaign that informed students of the issue, asked students what they want and need from a transit system and engaged them in helping find possible solutions. They hoped to do this through a campus-wide marketing campaign, student surveys, a possible trip to either Ames, Iowa or Champaign, Illinois with student leaders to see them a good student-centric bus system, etc. She noted it was probably unrealistic and unfair to expect students to take on the entire burden of the expansion being envisioned. Since a new system would provide a top class transit service for students, community members, local businesses and others, they wanted to look at a range of financing options and for the expansion to take place over an extended period of time. While she could not speak on behalf of all of the students at this time, she commented that a passionate few felt they could come up with a reasonable solution to help reinvent the Columbia Transit System.

There being no comment, Mayor McDavid continued the public hearing to the January 3, 2012 Council Meeting.

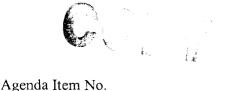

Engineer's Final Report and Levying Special Assessments

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration an ordinance accepting the Engineer's Final Report, accepting and approving the work, levying special assessments, issuing tax bills, approving and accepting Change Order No. 1 and Change Order No. 2, and appropriating funds, for the Broadway sidewalk project from Eighth Street to Ninth Street.

The resolution estimate was \$250,000 (\$125,000 for the sidewalk portion and \$125,000 for the waterline construction). The total sidewalk project cost was \$114,621.26 and the waterline construction cost was \$79,428.00. Funding for this project is from adjacent property owners, Water and Electric Capital Improvement project funds, and Capital Improvement Sales Tax funds.

DISCUSSION:

The project involved the reconstruction of sidewalk and installation of a 12" water main along the south side of Broadway from Eighth Street to Ninth Street. The existing sidewalk along this corridor did not meet the city downtown sidewalk standard. The sidewalks had excessive cross slope and at many locations the existing surface was deteriorated.

Included in the sidewalk project was electrical conduit for street lights, tree grates and decorative brick pavers. The length of sidewalk replaced was 187 feet. Two vaults under the sidewalk were filled and capped as well as two skylights. The parking area was patched and overlaid with asphalt.

The new 12" waterline connecting the existing waterlines under both Eighth Street and Ninth Street was constructed by Columbia Water & Light forces. The adjacent owners upgraded their water service pipe size to provide domestic service and for future required fire flow service. Replacing the existing service connections to the new line allowed disconnecting the existing service lines.

The Final Work Order is an increase of \$17,462.26 which includes Change Order No. 1 for the removal of the planter on the northeast corner of Broadway and Eighth Street, and Change Order No. 2 for the additional vault patching and backfill discovered while removing old sidewalk pavement in front of 806 and 810 E. Broadway.

According to city ordinance and policy, 50% of eligible sidewalk costs in the central business district are to be paid by special assessments levied against abutting properties. The eligible cost for the 50/50 split is \$45,716.50. If tax bills are assessed, they will \$22,858.25. The tax bill rate for this sidewalk project is \$122.2366 per abutting foot and was determined from contract bid prices.

FISCAL IMPACT:

The final cost for the sidewalk portion of this project is \$114,621.26 (\$46,357.76 city responsibility, \$45,716.50 eligible for 50/50 cost share and \$22,547.00 for street patching for water line). If levying special assessments against the lots and parcels abutting this sidewalk improvement is approved by Council, \$22,858.25 will be paid from tax bills.

The final cost for the waterline construction was \$79,428.00 and was paid from Water and Electric Capital Improvement funds.

VISION IMPACT:

Give proper funding, priority, and support to repairing, connecting, and expanding the city sidewalk system. Increase the pace of sidewalk improvements.

SUGGESTED COUNCIL ACTION:

Approve the ordinance accepting the Engineer's Final Report, accepting and approving the work, levying special assessments, issuing tax bills, and approving and accepting Change Order No. 1 and Change order No. 2, and appropriating funds, for the Broadway sidewalk project.

WHEREAS, construction of sidewalk improvements along the south side of Broadway, from Eighth Street to Ninth Street was authorized by Ordinance No. 020639 passed on June 7, 2010; and

WHEREAS, this public improvement has been completed by JC Industries, Inc.; and

WHEREAS, the Council has received the final report of the Director of Public Works in connection with this street construction, has held a public hearing prior to the commencement of the construction and has held a second public hearing regarding the levy and amount of special assessments in connection with the street construction project; and

WHEREAS, the Council has given due consideration to the comments of interested parties, the special benefits to the abutting properties, detriment, if any, to the abutting properties, the effect of the sidewalk construction on the present use of the property and general benefits to the general public in making the determinations set forth herein; and

WHEREAS, it is the determination of the Council that the properties fronting and abutting the sidewalk have realized one or more of the following special benefits as a result of the construction including, but not limited to, increased property values, salability of the properties, increased potential for future use, improved storm water drainage, improved access and parking; and

WHEREAS, it is the determination of the Council that the value of the special benefits to those properties fronting and abutting on the sidewalk is equal to, or greater than, the sum of \$122.2366 per abutting front foot.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized and directed to execute Change Order No. 1 and Change Order No. 2 to the contract with JC Industries, Inc. for the construction of sidewalk improvements along the south side of Broadway, from Eighth Street to Ninth Street.

SECTION 2. The nature and amount of the changes are set forth in Exhibit "A" and Exhibit "B" attached hereto and made a part hereof as fully as if set forth herein verbatim.

SECTION 3. The construction of sidewalk improvements along the south side of Broadway, from Eighth Street to Ninth Street is hereby accepted and approved.

SECTION 4. The report of the Director of the Public Works Department, who was charged with the responsibility of personally inspecting the work as it progressed to see that the work was done in accordance with the estimate, plans, specifications and contract, the ordinance governing the same and the Charter of the City is hereby approved and accepted.

SECTION 5. Special assessments are hereby levied at a rate of \$122.2366 per front foot against the lots and parcels of ground specially benefited by this public improvement and fronting or abutting along the distance improved, in proportion to the number of fronting or abutting feet. 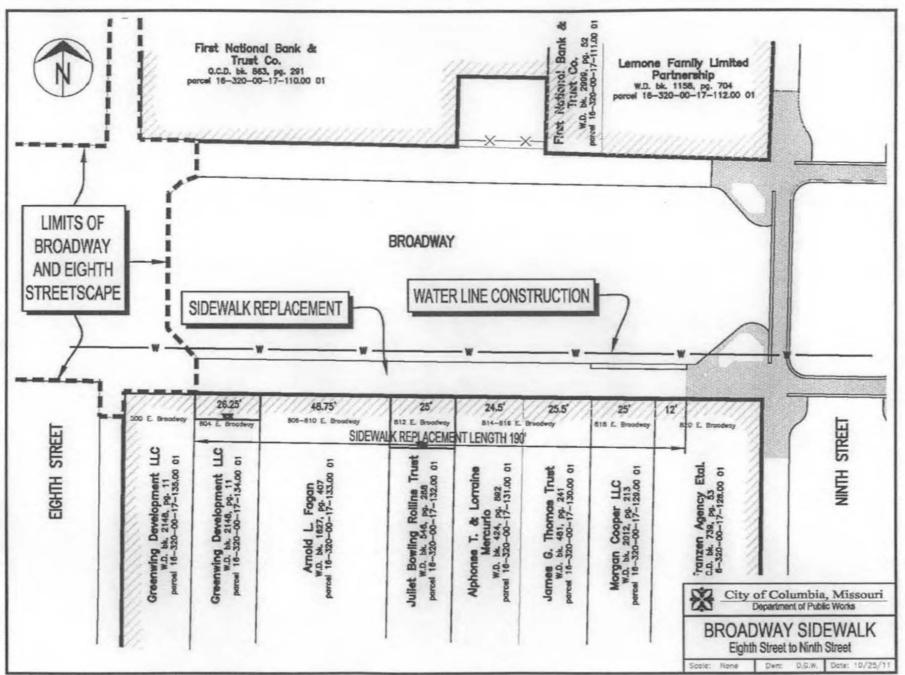

She felt it was best to find violations and enforce compliance as the violations were found instead of being overwhelmed with multiple violations when exposed. She thanked the Council for consideration of these two requests.

PUBLIC HEARINGS

B329-11 Authorizing Change Order No. 1 and Change Order No. 2 to the contract with JC Industries, Inc. for construction of sidewalk improvements along the south side of Broadway, from Eighth Street to Ninth Street; accepting the work on the Broadway Sidewalk Reconstruction Project; approving the report of the Director of Public Works; levying and assessing special assessments; appropriating funds.

The bill was given third reading by the Clerk.

Mr. Matthes provided a staff report and suggested Council pass this ordinance. He explained Mr. Fagan, who felt moisture in his basement had been caused by this project, could submit a claim through the City's Risk Management Division as there was disagreement between him and staff on that issue.

Mayor McDavid understood staff would report back to Council on Mr. Fagan's issue even if this project was closed out.

Mr. Schmidt commented that he had walked by when the work was being done and had seen the open vaults were filled with debris. As a layperson, he thought Mr. Fagan had a point and wanted to ensure the issue was resolved. His claim was that one vault was cleared out and filled in properly, but the other vault was not. He noted he could see the calcification from water seepage that had not been there when he had previously seen the apartments. He wanted to ensure this issue was not forgotten and was satisfied with the staff suggestion.

Mr. Kespohl stated he understood the vault was not filled in properly or had sunk due to water seepage. He noted he did not know whether it leaked before the sidewalk was installed, but felt the solution would be to not tax bill Mr. Fagan. He explained Mr. Fagan could use that \$6,000 to fix the problem himself, and if the cost was higher, he could go to Risk Management for the remainder of the money. He noted he thought City staff should oversee the project, but not do the work itself, to ensure the only work done was work necessary to resolve the water seepage issue.

Mr. Schmidt asked if the bill could be amended so Mr. Fagan was not tax billed. Mr. Boeckmann replied he would recommend a settlement agreement if there was a dispute instead of just moving forward in this manner. He thought they could remove the portion of the tax bill associated with Mr. Fagan's property and try to work out a settlement agreement. If that could not be accomplished, a separate ordinance imposing the tax bill for that property could be brought forward in the future. Mr. Kespohl believed that approach should be taken.

Mr. Schmidt asked if staff had any further comments. Mr. Glascock referred to specific vaults and explained there were voids under the concrete slab that looked exactly like the picture. They were not dug out. Two voids were fixed. He explained the purpose of the project was to put the sidewalk back, not to dig them out.

Mayor McDavid understood the suggestion was to not tax bill Mr. Fagan's property pending resolution. Mr. Matthes explained staff would come back to Council with a settlement agreement.

Mr. Kespohl made a motion to amend B329-11 by removing parcel number 16-320-00-17-133.00 01, which had a special assessment of \$5,959.03 from the legislation. The motion was seconded by Mr. Schmidt and approved unanimously by voice vote.

Mayor McDavid opened the public hearing.

Tom Schneider, an attorney with offices at 11 N. Seventh Street, stated he was representing Arnie Fagan, and in light of the amendment and the City Manager's proposed procedure, he did not need to further address the Council at this time.

There being no further comment, Mayor McDavid closed the public hearing.

The vote on B329-11, as amended, was recorded as follows: VOTING YES: MCDAVID, SCHMIDT, THORNHILL, KESPOHL, DUDLEY, ANTHONY, HOPPE. VOTING NO: NO ONE. Bill declared enacted, reading as follows:

(A) Voluntary annexation of property located on the north side of Bethel Drive, northeast of the intersection of Forum Boulevard and Old Plank Road.

Item A was read by the Clerk.

Mr. Matthes provided a staff report.

Mr. Kespohl asked if a church or school could be built on property zoned R-1. Mr. Teddy replied yes. Mr. Kespohl asked if the intention was to build a church or a house. Mr. Teddy replied he understood the desire of the church was to sell the property to an individual who would establish a daycare home. It would be a home that would operate a business of caring for children within the home and was permitted in the R-1 district with a limitation on the number of children that could be cared for. Mr. Kespohl asked for the limitation. Mr. Teddy replied the limit was for ten children all day and an additional three children part-time.

Mr. Schmidt understood they would be close to creating an island of an unincorporated area inside the City. Mr. Teddy agreed it would stand out because all of the neighboring lots within the subdivision were unincorporated, but the City limit was just to the north and adjacent to a street that would be extended from the City.

Mayor McDavid opened the public hearing.

There being no comment, Mayor McDavid closed the public hearing.

AN ORDINANCE

authorizing the City Manager to execute Change Order No. 1 and Change Order No. 2 to the contract with JC Industries, Inc. for the reconstruction of the sidewalk along the south side of Broadway, from Eighth Street to Ninth Street; setting forth the nature and amount of change; accepting and approving the work; approving the report of the Director of Public Works; levying special assessments and authorizing the issuance of special tax bills against the lots and parcels of ground specially benefited and abutting the improvements; appropriating funds; and fixing the time when this ordinance shall become effective.

WHEREAS, construction of sidewalk improvements along the south side of Broadway, from Eighth Street to Ninth Street was authorized by Ordinance No. 020639 passed on June 7, 2010; and

WHEREAS, this public improvement has been completed by JC Industries, Inc.; and

WHEREAS, the Council has received the final report of the Director of Public Works in connection with this street construction, has held a public hearing prior to the commencement of the construction and has held a second public hearing regarding the levy and amount of special assessments in connection with the street construction project; and

WHEREAS, the Council has given due consideration to the comments of interested parties, the special benefits to the abutting properties, detriment, if any, to the abutting properties, the effect of the sidewalk construction on the present use of the property and general benefits to the general public in making the determinations set forth herein; and

WHEREAS, it is the determination of the Council that the properties fronting and abutting the sidewalk have realized one or more of the following special benefits as a result of the construction including, but not limited to, increased property values, salability of the properties, increased potential for future use, improved storm water drainage, improved access and parking; and

WHEREAS, it is the determination of the Council that the value of the special benefits to those properties fronting and abutting on the sidewalk is equal to, or greater than, the sum of \$122.2366 per abutting front foot.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized and directed to execute Change Order No. 1 and Change Order No. 2 to the contract with JC Industries, Inc. for the construction of sidewalk improvements along the south side of Broadway, from Eighth Street to Ninth Street.
