Executive Summary

Staff has prepared a resolution to formally declare and approve the results of the municipal election held on April 5, 2016.

On April 5, 2016, votes were cast for the following municipal officers:

Council Member, Fourth Ward

Daryl Dudley	1,946
Ian Thomas	3,774

Based on the results of the election, Brian Treece was duly elected Council Member-at-large (Mayor), Karl Skala was duly elected Council member of Ward 3, and Ian Thomas was duly elected Council member of Ward 4. A resolution has been prepared to formally declare and approve the municipal election results.

Fiscal Impact

Short-Term Impact: The election costs have not yet been provided by the election authority. The final cost is apportioned among the various entities that placed an item on the ballot for any particular election.

The City's proportionate share for the April 2015 election was \$52,071.64; 19 entities had items on the ballot for that election. City of Columbia election items included filling council member positions for Wards 1, 2 and 6 as well as propositions for electric system revenue bonds, and stormwater utility charges.
