AN ORDINANCE

amending Chapter 14 of the City Code as it relates to parking limitations on a portion of Waugh Street; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 14 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Material to be deleted in strikeout; material to be added <u>underlined</u>.

Sec. 14-334. Parking time limited in designated places.

When signs are placed, erected or installed in each block or designated city parking lot giving notice thereof, no person shall park a vehicle for longer than the period of time hereinafter set forth. Changing of the position of a vehicle from one point directly to another within the same block or parking lot shall be deemed one continuous parking period.

(7) Twenty minute parking limit: Between 7:00 a.m. and 4:30 p.m. when Columbia public schools are in session:

Locust Street, south side, from Waugh Street to sixty (60) feet west of the west curbline of College Avenue.

Waugh Street, east side, from Locust Street to three hundred fifty (350) feet south of the south curbline of Locust Street, except that vehicles displaying hang tags 1 through 10 issued by Lee Expressive Arts School are allowed to park for twenty-four (24) hours.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.

Parking for Lee Elementary School Volunteers

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration an ordinance amending Chapter 14 of the City Code restricting parking on portions of Waugh Street to allow parking for Lee Elementary School volunteers.

DISCUSSION

At the August 6, 2012 Council meeting, a motion was passed approving a three month pilot project at Lee Elementary School authorizing parking on portions of Waugh Street for school volunteers. The project started in September.

To initiate the program, Lee Elementary School, with input from City staff, created unique hang tags that are not easily duplicated. City crews installed signs with the text, "EXCEPT LEE ELEM HANG TAG" below the existing 20 minute parking signs on Waugh Street. On September 10 and 11, a message board was placed on Waugh Street that flashed the message: 20 MIN MAXIMUM; and PARKING ENFORCED. Enforcement was heavy during the first two weeks of the pilot. Displacing the illegal all-day parking in the 20 minute zone was initially successful due to the message board and the enforcement.

After the first two weeks, enforcement was reduced to levels similar to other downtown streets. School representatives report that some illegal all-day parking has returned to Waugh Street, but there is enough free space to allow vehicles with Lee Elementary School hang tags. The school would like to continue the pilot project, and staff recommends Ordinance 14-334 be amended to allow the Lee Elementary hang tags on Waugh Street.
