## **EXECUTIVE SUMMARY:**

The Mid-Missouri Tourism Council has donated funds to the Office of Cultural Affairs in the amount of \$1,000 to augment the office's Small Request Funding process.

### **DISCUSSION:**

The Mid-Missouri Tourism Council (MMTC) recently held its annual, online auction. As in years past, the MMTC decided to donate part of the proceeds from the auction to the Office of Cultural Affairs. The OCA will use the funds to augment the Small Request Funding process. The Small Request Funding is available to non-profit arts agencies to help fund programming that is not part of the Annual Funding Process. The donation from the MMTC will bring the amount available in Small Request funding from \$3,000 to \$4,000 for FY13. These funds need to be accepted and appropriated to the correct account.
