EXECUTIVE SUMMARY:

This ordinance appropriates the tax credits received from the recent improvements to the intersection of Broadway and Eighth Street to fund future improvements to the Avenue of the Columns.

DISCUSSION:

On March 25, 2008 the City entered into a Tax Credit Agreement with the Missouri Development Finance Board to fund improvements to Eighth Street for the Avenue of the Columns Beautification Project. Pursuit to this agreement the City has received \$218,988 from the Missouri Development Finance Board as partial reimbursement for the recent improvements to Eighth Street at the Broadway intersection. Additional funds are needed to complete this beautification project. This ordinance appropriates the tax credit revenue to partially fund these future improvements.
