EXECUTIVE SUMMARY:

Staff has prepared for Council consideration a supplemental report concerning the public hearing for the Worley Street Sidewalk Phase 2 project. Attached is the Phone Contact Log that staff has prepared for this project.

Public Hearing - Worley Street Sidewalk Phase 2

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration a resolution setting a public hearing for April 1, 2013, for the construction of sidewalk improvements on the north side of Worley Street, from Bernadette Drive to Clinkscales Road, as shown on the attached location map. The concept cost estimate is \$194,500. An interested parties meeting for Worley Street Sidewalk Project was held January 30, 2013.

DISCUSSION:

The Community Development Block Grant (CDBG) program provides federal grants to local governments and states from the U.S. Department of Housing and Urban Development (HUD). The City of Columbia's Community Development department is responsible for dispersing the funds for a variety of projects. One of the purposes the money can be used for is construction of public facilities, or improvements that are geographically within the CDBG eligible areas. Within these parameters, \$194,500 has been allocated for the construction of Worley Street Sidewalk Phase 2 project.

On October 1, 2012, Council approved a resolution authorizing execution of an Engineering Services Agreement with the firm of Bartlett and West. The scope of services for this engineering agreement consists of the consultant providing engineering design and final construction plans necessary to construct the Worley Street Sidewalk Phase 2 project.

The project consists of constructing approximately 1,960 linear feet of sidewalk on the north side of Worley Street, from Bernadette Drive east to Clinkscales Road. The concept includes a five foot (5') wide sidewalk, drop inlets and approximately 250' of pipe to convey stormwater, and reconstruction of two crosswalks and nine driveways, to meet ADA requirements. Preliminary typical section and plan view diagrams are attached. The CDBG requires construction of this project to be completed by September 2014.

It will be necessary to acquire approximately 1,400 SF of permanent street easement, and approximately 15,000 SF of temporary construction easement from ten (10) property owners for this project. An Interested Parties meeting was held January 30, 2013; three (3) people signed in and were supportive of the project. Two (2) official comments were received (attached).

FISCAL IMPACT:

The funding source is a CDBG grant from the U.S. Department of Housing and Urban Development, and \$194,500 has been allocated for construction in FY 2014.



Following Council discussion and public input, Council should make a motion directing staff to proceed with plans and specifications for the project.



 - o In my view, this is a very important sidewalk project there are always a lot of pedestrians in this area and with no device to stop traffic between Clinkscales and Bernadette (a distance of nearly a half-mile), a sidewalk on one side of the street is inadequate. This project will almost certainly increase active transportation because of the large number of pedestrian generators in the area including the ARC and Farmers' Market, West Junior HS, the school district building, Claudell Square public housing, and low-wage jobs in restaurants, gas stations, etc.

 - I would echo Ian's comments that this sidewalk project would greatly contribute to community members' abilities to use active transportation in the area.





SECTION THROUGH PROPOSED SIDEWALK (STA. 11+52.77 TO STA. 14+13.65)




SECTION THROUGH PROPOSED SIDEWALK (STA. 14+25 TO STA. 15+50)







A RESOLUTION

declaring the necessity for construction of the Worley Street Sidewalk Phase 2 project on the north side of Worley Street between Bernadette Drive and Clinkscales Road; stating the nature of and the estimate of the cost of the improvement; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of a five-foot wide sidewalk on the north side of Worley Street between Bernadette Drive and Clinkscales Road, storm drain inlets and pipes, the reconstruction of two crosswalks and nine driveways to meet ADA requirements, and other miscellaneous work, all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, in the City of Columbia, Missouri, more specifically described as the Worley Street Sidewalk Phase 2 project, necessary to the welfare and improvement to the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 3. The estimated cost of this improvement is \$194,500.00.

SECTION 4. Payment for this improvement shall be made from Community Development Block Grant Funds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri. The City shall also cause to be inserted into the contract a stipulation that all laborers and mechanics employed by the contractor or subcontractors in the performance of work under the contract shall be paid wages at rates not less than those prevailing on similar construction in the locality as determined by the Secretary of Labor in accordance with the Davis-Bacon Act.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on April 1, 2013. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.
