INTRODUCTION

Section 21-49 of the City of Columbia Code of Ordinances outlines the duties of the Citizens Police Review Board. It states:

The citizens police review board shall have the following duties:

- (1) Review appeals from the police chief's decisions on alleged police misconduct as provided for in this article.
- (2) Host public meetings and educational programs for Columbia residents and police officers.
- (3) Review and make recommendations to the police chief and city manager on police policies, procedures and training.
- (4) Prepare and submit to the city council annual reports that analyze citizen and police complaints including demographic data on complainants, complaint disposition, investigative findings and disciplinary actions. The reports should also describe the board's community outreach and educational programs. The reports should also set forth any recommendations made on police policies, procedures and training. The reports shall be submitted no later than March 1 for the previous calendar year.

Pursuant to the requirements of Sec. 21-49, the Citizens Police Review Board has prepared and is submitting to the City Council this supplement to the 2012 Annual Report. This supplement contains information related to the demographic data on complainants, complaint disposition, investigative findings and disciplinary actions for police and citizen complaints.

The Columbia Police Department has also included information on external "concerns." Concerns are not defined by City Code. Some external "concerns" have the same description as assigned to some external "complaints." Because of this, it is unclear how the Columbia Police Department classifies or defines a concern.

ANALYSIS OF CITIZEN AND POLICE COMPLAINTS

When the 2012 Annual Report was prepared, the Citizens Police Review Board had not received a copy of the City of Columbia Police Department's 2012 Annual Report of the Internal Affairs Unit. The Board received the following documents and correspondence from the City of Columbia police department regarding the 2012 statistics. Columbia Police Department Internal Affairs Unit: 2012 Annual Report

The Columbia Police Department has finalized the 2012 year-end report from the Internal Affairs Unit. It will be posted on their website at www.gocolumbiamo.com.

During 2012, Columbia police officers were dispatched to 72846 calls for service in the City of Columbia. In addition, officers self-initiated 83602 calls/incidents, for a total of 156448 citizen contacts. CPD officers made 3887 in-custody arrests.

The Columbia Police Department has established the following categories with regards to the Use of Force:

- Balance Displacement
- Drawing/Exhibiting Firearms
- Handcuffing (without resulting in formal arrest)
- Impact Weapon (Baton)
- Impact Weapon (Other)
- Joint Manipulation
- Other Physical Force
- Pepper Spray
- Pressure Point Techniques
- Strikes

- Taser®
- Firearms Usage
- Canine Apprehension
- Canine Bite
- Chemical Gas (OC/CN/CS)
- Kinetic Energy Impact Device
- Horse Action/Movement

Officers used some degree of force during 438 incidents (0.0028% of all citizen contacts) during 2012. During those incidents, some degree of force was used against 562 subjects. Some of the incidents involved multiple subjects; some involved an officer attempting/using multiple types of force and/or multiple officers attempting/using some type of force. Note: a single incident with a particular arrestee can result in multiple reviews, because each individual use of force is reviewed.

The following represents the total number of uses of force by category:

- Officers used balance displacement on 200 occasions.
- Officers drew/exhibited their firearms on 285 occasions.
- Officers handcuffed subjects on 216 occasions (without resulting in formal arrest).
- Officers used joint manipulation on 129 occasions.
- Officers used other physical force on 72 occasions (any force used that did not fall into one of the other categories).
- Officers used pepper spray on 17 occasions.
- Officers used pressure point techniques on 23 occasions.
- Officers used strikes on 15 occasions.
- Officers used canine apprehension on (1) one occasion.
- Officers utilized their Tasers® on 21 occasions*:
 - o 19 consisted of laser display only
 - o (1) one consisted of Taser® display only
 - o (1) one projectile deployment
 - * The Taser® was only *deployed* (projectile deployment and/or drive stuns) against a subject on (1) one occasion.
- Officers did not employ force using any of the following categories: horse action/movement, impact weapon (baton or other), chemical gas, canine bite, and/or Kinetic Energy Device.

During 2012 of the 438 Use of Force incidents, 436 were determined proper and (2) two incidents are still pending.

During 2012, of the 438 Use of Force incidents, there were 38 reported injuries of subjects as a result of force used by officers (0.087% of all UOF incidents).

Of the 438 Use of Force incidents 32 officers were injured in conjunction with Use of Force (0.073% of all UOF incidents)

Officers used their firearms on 24 occasions for the dispatch of injured animals.

Columbia Police initiated 12 vehicle pursuits in 2012.

During 2012, Columbia Police officers received 60 compliments from external sources.

Of the 156448 citizen contacts, the Columbia Police Department received 104 complaints/concerns from external sources. Only 40 (external complaints) of those met the standards of City Ordinance 21-51 (approximately 0.00025% of all citizen contacts).

Finding Guidelines

- 1) **Unfounded** Where the act or acts complained of **DID NOT** occur or were misconstrued.
- 2) **Exonerated** Where the acts which provide the basis for the complaint occurred but the investigation shows the acts to be justified, lawful, and proper.
- 3) **Not Sustained** Where there is a failure to disclose sufficient facts to prove or disprove the act or acts complained of.
- 4) **Sustained** Where there are sufficient facts to prove the allegations made.
